#### Charleston County School District After-school Agreement

The USTA recently entered into a three-year agreement with the Charleston (S.C.) County School District to support the creation and the growth of tennis programming throughout the district. Over the next three years the school district will institute comprehensive afterschool tennis programs starting at 15 schools the first year, 30 schools the second year and 45 schools the third year. The school district's commitment to developing after-school programming is coupled with its efforts to build or paint QuickStart courts at elementary schools, support no-cut varsity teams at district high schools, and expand the district's spring middle school junior team tennis league. This partnership will result in a minimum of \$150,000 of school district resources being invested in the development and growth of tennis programming and facilities in the school setting over the next three years.

#### **QuickStart Tennis on the South Lawn of the White House**

On August 3rd, over 100 kids from six Washington NJTL chapters participated in a tennis clinic featuring the QuickStart play format on the South Lawn of the White House. This event was part of the USTA's ongoing effort to support First Lady Michelle Obama's Let's Move! initiative. Students were joined by Sam Querrey, the Bryan Brothers, Wayne Bryan and Lucy Garvin, and were treated to a surprise visit by President Obama.
