Committees. The fundamental role of each USTA committee is to advise the Board of Directors through appropriate organization channels. Committees use a consultative process with staff to research suggested or board-directed proposals; propose, refine, review, monitor, or evaluate programs, activities and budget allocations that are within the scope of the committee's duties; and provide timely recommendations to the board. Committees are generally headed by a committee chair who coordinates the committee's activities and deliberations.

Councils. To help the USTA carry out its mission, eight councils have been established. The primary purpose of each council is to facilitate communication between the Board of Directors and the committees aligned under each council heading, and to optimize council activities in support of the USTA's mission. The use of councils to assess and recommend priorities for initiatives and resources requested by committees also assists the board in making decisions and ensures that committee proposals are broadly constructed. Each council brings together the chair of each of the committees aligned under that council heading under the leadership of the council chair.

All council chairs, committee chairs, and committee members are appointed by the Chairman, CEO and President of the USTA.
