FROM AIRPORT TO HOTEL

- TAKE NIMITZ HIGHWAY HEADING EAST.
- NIMITZ EVENTUALLY BECOMES ALA MOANA BOULEVARD.
- PASS ALA MOANA SHOPPING CENTER ON THE LEFT.
- FROM ALA MOANA BOULEVARD, TURN RIGHT ONTO KALAKAUA AVENUE.
- CONTINUE ON KALAKAUA AVENUE FOR APPROXIMATELY 1.5 MILES.
- TURN LEFT ONTO LIL'UOKALANI - THE ENTRANCE TO THE HOTEL IS ON THE IMMEDIATE RIGHT.

FROM AIRPORT TO SITE

- HEAD TOWARD AOOLE STREET ON RODGERS BOULEVARD.
- BEAR RIGHT ONTO AOOLE STREET.
- BEAR RIGHT TO STAY ON AOOLE STREET.
- BEAR RIGHT TOWARD COMMUTER TERMINAL.
- TURN RIGHT TOWARD NIMITZ HIGHWAY.

- TAKE THE HI-630/KAILUA EXIT ONTO MOKAPU SADDLE ROAD TOWARD KAILUA.
- CONTINUE ON MOKAPU BOULEVARD & TURN RIGHT ONTO ONEAWA STREET.
