## **DIRECTIONS**

FROM ORLANDO AIRPORT TO HOTEL(HILTON): 1. Start out going SOUTH on AIRPORT BLVD. 0.9 mi 2. Turn SLIGHT LEFT to take the ramp toward TERMINAL B/SR-436/NORTH EXIT/SR-528-TOLL. 0.1 mi 3. Stay STRAIGHT to go onto AIRPORT BLVD. 1.5 mi 4. Merge onto SR-528-TOLL E via EXIT 1A toward COCOA/KENNEDY SPACE CENTER (Portions toll). 30.7 mi 5. Merge onto 1-95 S via EXIT 42A toward MIAMI. 21.9 mi 6. Take the SR-518/EAU GALLIE BLVD exit, EXIT 183, toward MELBOURNE/INDIAN HARBOUR BCH. 0.3 mi 7. Take the ramp toward DOG TRACK/MELBOURNE/BEACHESS. Turn LEFT onto SR-518 E/EAU GALLIE BLVD W. Continue to follow SR-518 E. If you reach I-95 S you've gone about 0.3 miles too far 8.0 mi 8. Turn SLIGHT RIGHT onto HIGHWAY A1A N/SR-A1A. HIGHWAY A1A N is 0.1 miles past SAN JUAN DR 0.3 mi 9. 3003 N HIGHWAY A1A. You've gone a little too far.

FROM MELBOURNE AIRPORT TO HOTEL(HILTON): 1. Start out going SOUTH on AIR TERMINAL PKWY toward HARRY SUTTON RD. 0.4 mi

2. Turn LEFT onto W NASA BLVD/SR-508 E. W NASA BLVD is 0.1 miles past TED HUFF RD 0.3 mi 3. Turn LEFT onto AIRPORT BLVD. AIRPORT BLVD is 0.1 miles past AIR TERMINAL PKWY 0.5 mi 4. AIRPORT BLVD becomes APOLLO BLVD S. 1.8 mi 5. Turn RIGHT onto SARNO RD. SARNO RD is 0.3 miles past ST MICHAEL PL 0.5 mi 6. Turn LEFT onto N HARBOR CITY BLVD/US-1/SR-5. 0.5 mi 7. Turn RIGHT onto MONTREAL AVE/SR-518 E. Continue to follow SR-518 E. (SR-518 E is just past OLD OAK ST) 3.1 mi 8. Turn SLIGHT RIGHT onto HIGHWAY A1A N/SR-A1A. (HIGHWAY A1A N is 0.1 miles past SAN JUAN DR) 0.3 mi 9. 3003 N HIGHWAY A1A. Your destination is 0.1 miles past OCEANSIDE BLVD (If you reach NORTH CT you've gone a little too far)

FROM 95 SOUTH TO SITE: EXIT ON EAU GALLIE BLVD & GO LEFT TOWARDS THE BEACH. GO APPROX 8 MILES ON EAU GALLIE UNTIL YOU GO OVER BRIDGE. MAKE FIRST LEFT AFTER BRIDGEONTO 513/SOUTH PATRICK DRIVE. GO 1 1/2 MILES TO TRADEWINDS DRIVE MAKE LEFT ON TRADEWINDS DRIVE. YOU WILL SEE KIWI TENNIS CLUB SIGN ON LEFT. MAKE FIRST RIGHT INTO CLUB.
