

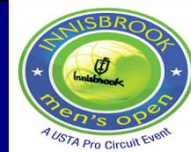

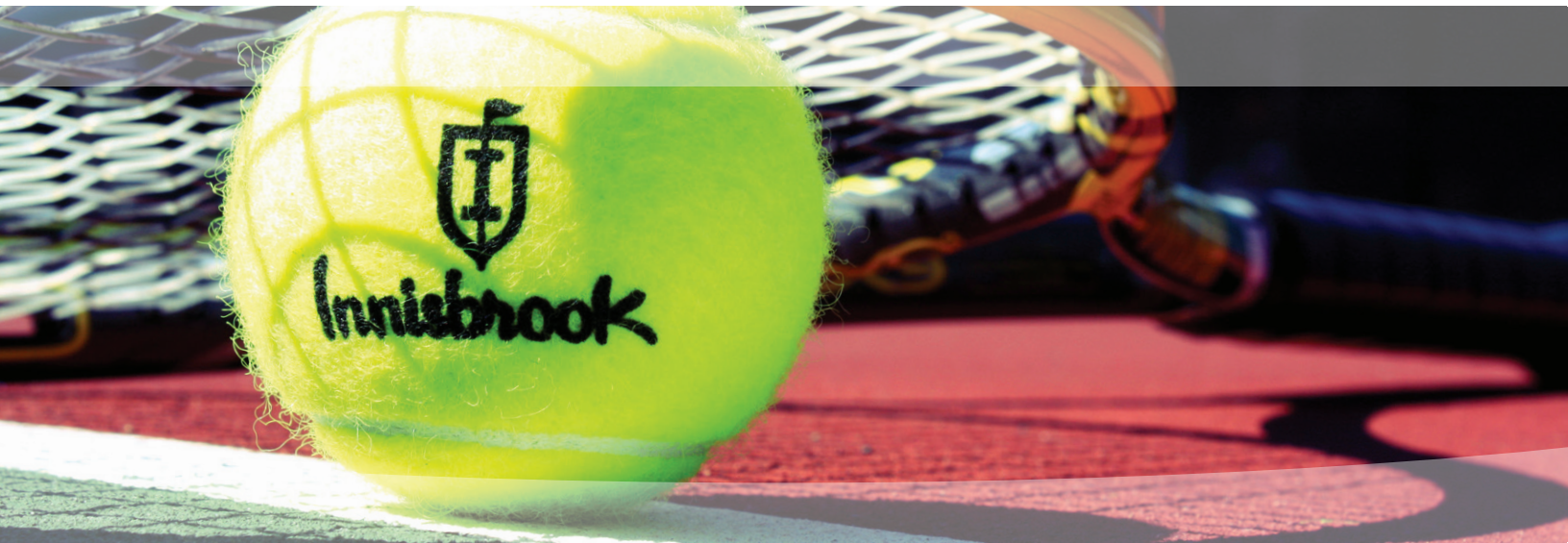
FROM TAMPA AIRPORT TO HOTEL/SITE: TAKE THE EXIT TO LEAVE THE AIRPORT ON THE RIGHT HAND SIDE. FOLLOW THE SIGNS AND TAKE THE HIGHWAY 60/CLEARWATER/VETERANS EXPRESS EXIT. TAKE FLORIDA HIGHWAY 60 WEST (COURTNEY CAMPBELL CAUSEWAY) FOR APPROXIMATELY 13 MILES TO U.S. HIGHWAY 19 NORTH OVERPASS ON THE RIGHT SIDE OF THE ROAD. FOLLOW U.S. HIGHWAY 19 NORTH 10 MILES NORTH TO INNISBROOK DRIVE. TURN LEFT ONTO INNISBROOK DRIVE AND PROCEED THROUGH THE 2 STOP SIGNS INTO THE RESORT.
