FROM AIRPORT TO HOTEL: TAKE I-440 W TO EXIT 138A (I-30 E) TO EXIT 139B (I-630 W). FOLLOW 7 MILES THEN TURN RIGHT ONTO SHACKLEFORD TO CROWNE PLAZA. TO HAMPTON INN & SUITES TURN LEFT ONTO SHACKLEFORD. PASS KANIS STOPLIGHT AND THEN TURN LEFT INTO HOTEL PARKING LOT.
FROM AIRPORT TO SITE: TAKE I-440 W TO EXIT 138A (I-30 E) TO EXIT 139B (I-630 W). MERGE ONTO EXIT 8A (1-430 N). TAKE RODNEY PARHAM ROAD EXIT NORTH RAMP (EXIT 8). TURN LEFT ONTO N. RODNEY PARHAM ROAD. TURN RIGHT TO STAY ON N. RODNEY PARHAM ROAD. TURN LEFT ONTO PLEASANT VALLEY DRIVE.
FROM HOTEL TO SITE: GO SOUTH ON S. SHACKLEFORD ROAD TOWARD BIRCHWOOD DRIVE. TURN LEFT ONTO I-630 E. MERGE ONTO I-430 N VIA EXIT 8A. TAKE RODNEY PARHAM ROAD EXIT NORTH RAMP (EXIT 8). TURN LEFT ONTO N. RODNEY PARHAM ROAD. TURN LEFT ONTO PLEASANT VALLEY DRIVE.
