\*\*\*\*Rules & Regulations: All players must sign-up for this tournament by utilizing their IPIN. No fax entries to the tournament or USTA will be accepted. This is an ITF Grade 4 tournament. The withdrawal deadline (done online through IPIN) for all ITF Junior Circuit Tournaments will be 1400 GMT 13 days prior to the Monday of the tournament week (Tuesday March 8th). Players will be able to withdraw without penalty until that time. The freeze deadline for all ITF Junior Circuit Tournaments will be 1400 GMT on the Wednesady prior to the tournament week (Wednesday March 16th). From that time, players who are on the qualifying list will no longer move into the main draw and players who are qualifying alternates will no longer move into qualifying. Vacancies on-site will be filled by signed-in alternates (for qualifying) & lucky losers (for main draw). It is the responsibility of the player ONLY to enter and withdraw from events.
