TURN LEFT ONTO WHITFIELD AVENUE/GA-204 SPUR. CONTINUE TO FOLLOW GA-204 SPUR E. MAIN GATE TO SITE WILL BE STRAIGHT AHEAD. ONCE PASS MAIN GATE, BEAR RIGHT AND ENTRANCE WILL BE ON THE RIGHT.
