Districts: April 17 - 19, 2020 in Casper (Wyoming Athletic Club)

Levels: Combines 6.0, 7.0 and 8.0 **Format:** Three doubles per team

Initial Team Registration Deadline: March 27

Sectionals: July 10-12, 2020 (Boise, ID)

USTA 40 & OVER MIXED DOUBLES: (for those 40 and over this calendar year)

Districts: May 1 - 3, 2020 in Cheyenne (location TBD)

Levels: Combines 6.0, 7.0 and 8.0 **Format:** Three doubles per team

Initial Team Registration Deadline: April 10

Sectionals: October 9 - 11, 2020 (TBD)

TRI-LEVEL 18 & OVER LEAGUE: (for players 18 and over at the start of the league*)

Local League: May 15 – July 5, 2020 (in each community that fields 2+ teams)

Levels: Men's and Women's levels 3.5/4.0/4.5

Format: Three doubles per team, each line at different NTRP level (3.5/4.0/4.5) Players compete against same gender/ability.

Initial Team Registration Deadline: May 3

Districts: July 17 - 19, 2020 in Casper (Wyoming Athletic Club)

Sectionals: Mid-January 2021 (TBD)

USTA ADULT 18 & OVER: (for players 18 and over at the start of the league*)

Districts: June 5 - 7, 2020 in Laramie (University of Wyoming Tennis Complex)

Levels: Men's and Women's 3.0, 3.5, 4.0, 4.5, Women's 2.5

Format: 2.5's (1 singles and 2 doubles), all others (2 singles and 3 doubles)

Sectionals: Aug. 14 - 16, 2020 (Salt Lake City, UT)

USTA 65 & OVER: (for those 65 and over this calendar year)

Districts: June 5 - 7, 2020 in Laramie (University of Wyoming Tennis Complex)

Levels: Combines 6.0, 7.0 and 8.0 **Format:** Three doubles per team

Initial Team Registration Deadline: April 27

Sectionals: Early November 2020 (TBD)



USTA ADULT 55 & OVER: (for those 55 and older this calendar year)

Districts: June 26-28, 2020 in Cheyenne (location TBD) **Levels:** Men's and Women's combined 6.0, 7.0 and 8.0

Format: Three doubles per team

<u>Initial Team Registration Deadline: May 22</u> Sectionals: Sept. 18 -20, 2020 (Denver, CO)

USTA ADULT 40 & OVER: (for those 40 and older this calendar year)

Districts: August 7 - 9, 2020 in Laramie (University of Wyoming Tennis Complex)

Levels: Men's 3.0, 3.5 and 4.0 and Women's 3.0, 3.5 and 4.0

Format: One singles and three doubles per team
Initial Team Registration Deadline: July 17

Sectionals: September 11 - 13, 2020 (Denver, CO)

ITA MIXED DOUBLES: (for players 18 and over at the start of the league*)

Districts: October 2 - 4, 2020 in Casper (Wyoming Athletic Club)

Levels: Combined 5.5, 6.5, 7.5 and 8.5 **Format:** Three doubles per team

<u>Initial Team Registration Deadline: September 11</u> Sectionals: October 23 - 25, 2020 (Las Vegas, NV)
