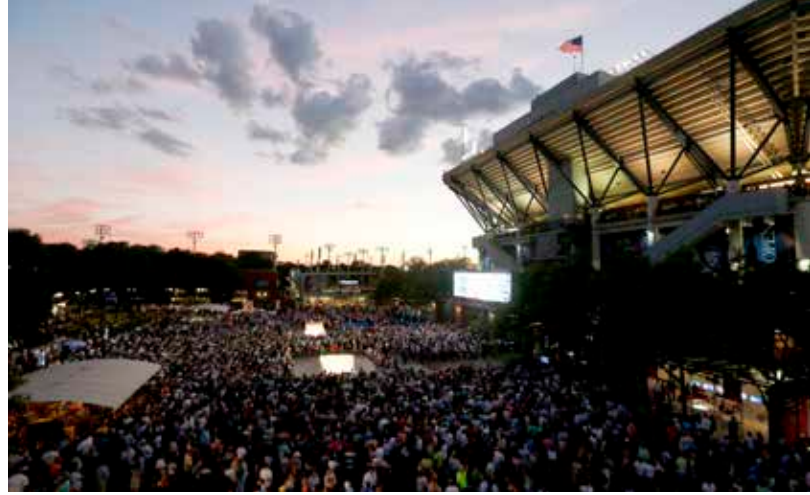

Renewal of any subscription or ticket plan is at the sole discretion of the USTA and the USTA reserves the right for any reason whatsoever not to renew any subscription or ticket plan or to change the seat location previously assigned to any subscription or ticket plan. Upon receipt of tickets, risk of loss or theft of tickets shall pass to subscriber or ticket plan holder; the USTA shall not be obligated to admit subscriber or ticket plan holder to events unless applicable tickets are presented at such time.
