## RULES

### Player Eligibility

- **Minimum Two matches where one default can count for Districts/Sectionals .**
- **Minimum Three matches where one default can count for Nationals.**

Captains are responsible for ensuring that all players listed in their line-up have NOT played in post-season matches for another team at the same level. Players must present Photo ID when requested by staff.

### Grievances

NTRP grievances will be accepted but not processed during this event. If a NTRP grievance is upheld, the player affected will not be able to proceed to the next championship level at the original rating level.
