Blended Lines

Tired of taping down lines for your kids programs? Receive 100% funding to paint permanent lines on your courts. *

- If approved, courts that are available to the public will receive 50% from USTA and 50% from USTA Texas through reimbursement.
- If approved, private clubs will receive 50% from USTA and 25% from USTA Texas through reimbursement.
- Consider schools, public facilities, blacktops, parking lots, basketball courts, and etc...

* Up to a reasonable price per court and based on agreeing to the deliverables below.

USTA Facility Matching Funding *

Categories	Funding Description	USTA Contribution
Category I	Basic facility improvements, including fixed court amenities (i.e. backboards, fencing, windscreens, etc.)	Up to 50% of total project cost (\$4k max)
Category II	Resurfacing of existing 36', 60', and 78' courts. Converting an existing 78' court to stand-alone 36' courts. Lighting.	Up to 50% of total project cost (\$10k max)
Category III	New construction or existing facility reconstruction of 36', 60', and 78' courts.	Up to 50% of total project cost (\$20k max)

* USTA Texas will evaluate and award additional funding for approved USTA facility grants based on a first come, first serve basis.

Grant Process

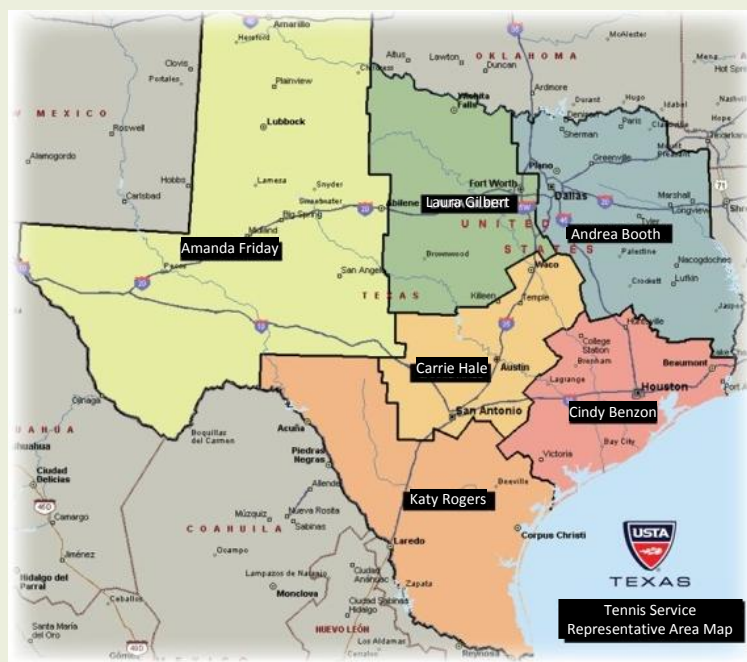
1. Talk to your local USTA Texas Tennis Service Representative and/or Todd Carlson (tcarlson@texas.usta.com).
2. If agreed to move forward, complete the USTA facility funding form. (<http://ct.usta.com/pfa/>)
3. USTA Texas' evaluation committee will assess the application and create an award/rejection letter.

Facility Deliverables

- Provide access to courts and bathrooms (amount varies)
- Provide entry level tennis programming (amount varies)
- Provide a 6 month and 12 month update
