ENTRY INFORMATION AND TOURNAMENT REGULATIONS

Tournament Endorsement List

Each Section may enter one team with a minimum of six players and a maximum of seven players. NO Section may enter more than one team. Players may only play for their own Section; they may not play a team match for another section.

Junior players are selected by their Section to represent the Section in the Tournament. Sections have varying methods for player selection (endorsement) and are solely responsible for communicating selection procedures to their players.

Each Section MUST COMPLETE a Team Endorsement List and return it to the tournament no later than June 30, 2019. The Team Endorsement List MUST include the following information:

- Player Information: The names of six or seven players representing the Section, the players USTA Membership Number and date of birth. If possible, include the Players Graduation Year. Players are to be listed IN ORDER OF STRENGTH, determined by the Section.
- Coach Information: The name of the designated team coach and their contact information MUST appear on the list.
- **Signature of Sectional Endorser:** The Team Endorsement list must have the signature of the Sectional Endorser to be official.

The following rules will apply to each participant in the 2019 USTA Boys 18 National Team Championship:

- Each team member must have a current USTA Membership
- The Section is responsible for ensuring that a USTA Parental Release is on file in the USTA National Offices.
- The Player must be eligible according to USTA Rules/Guidelines
- Each team member must be endorsed by his Sectional Association and be a legal resident of the Section.
- The Tournament will be conducted under guidelines outlined in the USTA Friend at Court.

The Sectional Office is responsible for completed the Team Endorsement List and paying the 400.00 entry fee. The Entry Form can be found in the Appendices of this manual. Please make your check payable to Eric Voges. Entry Fee MUST be accompanied by the Entry form and is due June 30, 2019. Mail Payment to:

Eric Voges McCallie School 500 Dodds Ave. Chattanooga, TN 37404 Only the Section may make changes to the Team Endorsement List (replacement of withdrawing players and/or change to the order of endorsement). Coaches MAY NOT make any changes to the list. Changes to the Team Endorsement List must be made in writing to the Tournament Director no later than three days prior to the start of the tournament. Any emergency changes to the participating players required past the deadline will be handled by the Tournament Committee.

Team Coaches

All Sectional Teams must have only one adult who shall be designated by the Section as the Team Coach on the Team Endorsement List. This individual shall serve as the chaperone and is responsible for the supervision of the team during the event. Coaches are required to exemplify the highest standards of conduct, including but not limited to, fair play and sportsmanship. Coaches should consider themselves role models for players.

Each Section will be responsible for the designated coaches' expenses.

The coaches MUST stay with the team at the hotel until the last member of the team has finished the competition on the last day of play with the intent to return home, or travel to another tournament. Coaches are responsible for player safety and conduct at all times. Coaches are not permitted to leave their players in the care of another team coach or chaperone.

Coaching During Matches:

A player may be coached by the designated team coach during the match. ONLY the designated team coach may coach during competition. Coaching must be carried out in a manner that does not distract play on any adjoining court. The coach may enter the court ONLY during a changeover or set break. On-court coaching must be done from the net post area or player bench area. Off court coaching must be done from outside the fence, and must not interrupt play or be distracting to play on an adjacent court.

We welcome all parents and personal coaches to the event, but these individuals will be SPECTATORS throughout the event.

Team Line-Up

A Section's line-up for each team match must be submitted to the Head Referee (or Head Referee's Designate) thirty minutes prior to the start of the team match. No changes to the team line-up may be made except for illness, injury, or personal emergency. Any changes to the team line-up are subject to approval of the Tournament Committee. A player who does not play or retires from their singles match due to injury, illness, or personal emergency is eligible to play doubles on the same day.

Singles Line-up: Players must play in positions that are in the order determined by the Section on the Team Endorsement List. When a player is removed from the Singles line-up, all players will be moved up as necessary, and the No 7 Singles Player will compete at the No 6 position.

Doubles Line-up: Doubles line-up combinations will be determined by the Coach. Coaches must use good faith in determining the order of strength, and matches must be played in order of strength.

Minimum Matches: If a Section sends a team with 7 players, every team member must play in at least one official team match per day and at least one official team singles match during the entire competition. (i.e. the no 7 Singles player can play doubles every day, but MUST play singles on one day of competition).

Tournament Format

The USTA Boys 18 National Team Championships shall use a Compass Draw (Available in Appendix D). ALL Singles Matches shall consist of the Best of 3 Tie-Break Sets. All Doubles Matches shall consist of an 8 game pro-set, with a set Tie-break at 7-7. Regular scoring shall be used in all Matches.

Each team match between two Sections shall consist of 3 Doubles Matches followed by 6 Singles Matches. ALL Singles and Doubles matches will be played to completion. A total of 7 points will be awarded during each match. Each Section will receive one point for each singles match won, and the Section who wins the majority of the Doubles matches (2 of 3) will receive additional point. Defaults, walkovers, withdrawals, and retirements will count as losses.

If an even number of matches are played (due to inclement weather), the winner of the doubles point/team match will be determined in the following successive steps:

- 1. Highest percentage of sets won of all sets completed
- 2. Highest percentage of games won of all games completed
- 3. Coin Toss

Any match played between two substitute players from a Section that are not listed in the team line-up will NOT count toward the team match score and will not count for National Junior Ranking Points.

After the completion of a dual match, the coaches of both teams MUST sign the score sheet.

Seeding

The National Standing Lists will be used for seeding teams. The Tournament Committee may use additional seeding resources including UTR, the advice of USTA National Coaching Staff and ATP/ITF ranking lists to determine seeding strong players who may not appear on the National Standing List. The Tournament Committee will seed 8 teams numerically.



Delta Airlines operates the most daily flights (most out of Atlanta, but also daily from Detriot, and New York, LGA). United Airlines offers service from Chicago as well as Washington-DC. The Atlanta International Airport (ATL) is 127 miles to Chattanooga. The Atlanta Airport offers the most options for travel, and the airport is located on the southern side of Downtown Atlanta. The Nashville International Airport (BNA) is 132 miles to Chattanooga. The Nashville Airport offers numerous daily flight for all major airlines as well as Southwest.
