### HOW TO APPLY: GRANT REQUIREMENTS & ACCOUNTABILITY:

- Send ***one*** copy of the completed grant application by **December 31, 2018** to the Idaho Tennis Association, attn: D&I Grant, 1076 N. Cole Rd.; Boise, ID 83704.
- Create a plan that addresses **ONE** of the district's greatest diversity and inclusion needs. Your plan must include the following:
  - Detailed overview of what you are going to do.
  - Outline results you expect to achieve by December 31, 2018.
  - A system for tracking results of this effort. i.e. how will you determine whether your effort has been successful?
  - A signature from the person responsible for executing your plan.
- An accountability report is due to the IdTA on or before January 15, 2019. Failure to provide a report or failure to use the grant for the requested purpose will jeopardize your eligibility for a grant in the future.

The maximum grant amount awarded is \$1,000 for any one organization member or CTA. We reserve the right to award less than \$1,000 if your plan is deemed "light" by the grant review team.

By completing and signing this form, the Organization Member agrees to provide the IdTA a final report by **January 15, 2019**. We also recognize that being held accountable for the funds we receive by reporting our results and best practices will improve our chances for additional funding in the future.
