



CompTIA Candidate Rules Agreement

Please review and accept the following exam rules:

- € I will not have the following types of personal items anywhere nearby during test delivery: cellular phones, hand-held computers/personal digital assistants (PDAs), cellular phones, or other electronic devices, pagers, watches, purses, hats (and other head coverings), bags, coats, books and notes. Religious items such as head coverings, Rosary beads, Kabbalah bracelets, etc. are permitted in the testing room after being visually inspected by the test administrator. Similar to any other clothing or jewelry, any religious items allowed to be worn in the testing room must remain on your person at all times.
- € I will store these items in a secure area indicated by the proctor. Cellular phones, pagers, and other electronic devices must be turned off prior to placing them in the designed secure area.
- € The proctor will take control of my personal computer, after asking for permission to do so, check for unauthorized programs running in the background, provide the URL to launch the exam, verify that I am taking the intended exam and then authorize delivery of the exam using proctor credentials. I will remain in the same area until completion of the exam or until the proctor shuts down the exam.
- € I understand that eating, drinking, smoking, chewing gum and making noise that creates a disturbance are prohibited during the exam.
- € The proctor will monitor me continuously while I take my exam. The session may be videotaped or otherwise recorded for security or other purposes.
- € If I experience problems that affect my ability to take the exam, I will notify the proctor **immediately**.
- € The proctor cannot answer questions related to exam content. If I have questions of this nature, I will contact the exam sponsor after I complete the exam.
- € If I take an unscheduled break at any time, the exam timer will NOT be stopped. The proctor will set my workstation to break mode, and I will take my ID with me when I leave the room. The proctor will check my ID before I return to my seat to continue taking my exam.
- € If I take an unscheduled break, I am NOT allowed access to personal items other than medication required at a specific time and with approval of the proctor. Items that are not permitted include but are not limited to: Cellular phones, exam notes and study guides.
- € I will not try to remove copies of exam questions and answers from the testing computer, and I will not share or discuss the questions or answers seen in my exam with other candidates.
- € After the exam ends, the proctor will ensure my exam has ended properly.

Your privacy- *Your exam results will be encrypted and transmitted to Pearson VUE and CompTIA. The testing software does not keep any information other than when and where your exam was taken.*

Candidate Statement: *By checking the box "I have read and agree to the CompTIA Testing Policies listed above", I give CompTIA my explicit consent to retain and transmit my personal data and test responses to Pearson VUE and to CompTIA (either of which may be outside of the country in which I am testing). I understand the information provided above and agree to adhere to this Candidate Rules Agreement. If I do not follow this Candidate Rules Agreement, the Candidate Agreement, or I am suspected of cheating or tampering with the computer, this will be reported to CompTIA, my exam may be invalidated, and other action may be taken such as decertifying me, and I will not be refunded my exam fee.*
