Summary/Objective:

The Executive Director (ED) is the strategic leader of the organization. The ED bears responsibility for the financial, operational, and administrative management of the organization. In this capacity, the ED is responsible for the achievement of adequate fundraising and for the fiscal stewardship of the organization's funds. This position reports to and works in partnership with the Board of Directors and is responsible for implementation of policies set by the Board as well as annual goals and objectives.

Skills and Abilities Required:

- Proven leadership skills; leading, managing, and supervising diverse groups
- Skilled with collaborating, networking and excels at building working relationships with community partners
- Self-motivated, enterprising and creative problem solver exhibiting sound judgment
- Exceptional written, verbal and interpersonal communication skills
- Proficiency in preparing financial documents, reports, and budgets
- Professional conflict resolution skills
- Capacity to guide strategic planning and implementation of organization's long-term goals

Special Work Requirements / Responsibilities:

- 4) Highly proficient written and verbal communication skills; must be demonstrable with work experience.
- 5) Drivers' License - Must possess a valid State of Montana driver's license (or the equivalent in another State, with eligibility to be licensed in Montana).
