

What is MyFreeTaxes?

MyFreeTaxes is an online tax filing program that helps people file their federal and state taxes for free while getting the assistance they need.

United Way provides MyFreeTaxes in partnership with the IRS's Volunteer Income Tax Assistance (VITA) program to help filers prepare their tax returns on their own or have their return prepared for them for free.

For millions of Americans, tax refunds and credits are essential to their financial stability and success. These credits maximize filers' refunds and provide important opportunities for individuals and families to build financial stability. For many households, their tax refund may be the biggest check they receive all year.

That is why United Way provides MyFreeTaxes. Since 2009, MyFreeTaxes has helped more than 1.3 million people file their taxes for free while claiming over \$1 billion in refunds and saving over \$260 million in filing fees.

Why United Way Created These Guides

- Better support for MyFreeTaxes users
 - 10% of MyFreeTaxes users have self-employment income and could benefit from these additional resources

- Scale access to safe, easy, and free tax filing for LMI entrepreneurs
 - o 17% 28% of households (26 million 44 million) have self-employment income

 - Only about 6% of VITA and TCE returns include Schedule C for self-employment income

Small businesses play a critical role in our economy, generating income and wealth that supports the financial needs of entrepreneurs, employees, and their families. However, the costs and stress associated with filing business-related taxes limit the positive financial impacts of self-employment for many entrepreneurs.

According to the IRS, in 2019, there were over 27.8 million sole proprietorships (also called self-employed individuals) running businesses in the United States. In a way, this isn't surprising. To start a business as a sole proprietor, you typically just need to start doing your business. That is, there's little or no registration needed and no incorporation forms to fill out. Sole proprietorships can include anything from a person selling crafts on Etsy to a take-out restaurant with multiple employees. They all have one thing in common- they report their business earnings (and determine their taxes) using a Schedule C form.

Small business and self-employment play a critical role in our economy, generating income and wealth that supports the financial needs of entrepreneurs, employees, and their families. However, the costs and stress associated with filing business-related taxes limit the positive financial impacts of self-employment for many entrepreneurs.

In 2021, the gig economy included over 59 million workers in the US. The gig economy includes a variety of independent contractors, typically taking on short-term assignments such as Lyft or Uber drivers, DoorDash and other food app delivery drivers, Instacart workers, promoters, brand ambassadors, graphic designers, freelance writers, and more. Often, gig economy entrepreneurs have other full or part-time "regular" jobs where they work as employees, but increasing numbers are making their self-employment gigs their only jobs.


