About AMSSA

AMSSA (the Affiliation of Multicultural Societies and Service Agencies of BC) is BC's province-wide umbrella association with over 80 member organizations who build culturally inclusive communities. First established in 1977, AMSSA provides opportunities for its members and others in the settlement and integration community to exchange knowledge, build connections and engage with government with a unified voice. With a BC-wide perspective, AMSSA works to address emerging issues and build capacity for the BC Settlement sector.

AMSSA has multiple funding streams including Immigration, Refugees and Citizenship Canada (IRCC) to provide support to IRCC contract holding agencies in BC as well, AMSSA is funded by the Province of British Columbia to provide support to BC Settlement and Integration Services (BC SIS) contract holders. AMSSA also receives funding from the Government of Canada's Migrant Worker Support Network, led by Employment and Social Development Canada (ESDC) to support the capacity building of organizations supporting Migrant Workers. Other funders include Canadian Heritage, WorkSafeBC, Vancouver Foundation and other government and research bodies.

In March of 2019, AMSSA started the project "Building Capacity to Support BC's Migrant Workers". This project is funded by the Government of Canada's Migrant Worker Support Network, led by ESDC.

British Columbia Pilot

2016

The 2016 HUMA (Parliamentary Standing Committee on Human Resources, Skills and Social Development and the Status of Persons with Disabilities) Report iterated concerns about TFWs being mistreated or abused, and the need for better enforcement as well as education to TFWs to empower them to exercise their rights.

2017

The Auditor General's report in 2017 reiterated concerns about TFWs being mistreated or abused, and the need for better enforcement as well as education to TFWs to empower them to exercise their rights. In 2017, consultations facilitated by the Federal Government with key stakeholders and partners involved in the protection of TFWs identified a clear need for collaborative engagement on the issue of TFW protections.

2018

Government of Canada announced that it planned "to establish, on a pilot basis, a network of support organizations for temporary foreign workers dealing with potential abuse by their employers. This network would support these workers in reporting wrongdoing and provide information on their rights to temporarily remain and work in Canada free from harassment and abuse".

Further consultations were conducted to highlight current challenges faced by TFWs in BC as well as the potential design of the network's governance structure. The network needed to be migrant worker-centered and focused on issues such as addressing retribution, improving TFWs' access to resources and services, and better educating employers on their responsibilities under the TFW Program.

OCT 2018

THE MIGRANT WORKER SUPPORT NETWORK LAUNCHED!

The first official plenary meeting and working groups meetings were held in Richmond, B.C.

EARLY 2019 Funding projects under the Migrant Worker Support Network are launched. The projects focus on three areas: providing on-arrival information and orientation services to migrant workers; building resources and an information toolbox for organizations supporting migrant workers; and supporting migrant workers through project-based community capacity building and outreach. Funding is provided until March 31, 2020.

JAN 2019 -MAR 2020 The Auditor General's report in 2017 reiterated concerns about TFWs being mistreated or abused, and the need for better enforcement as well as education to TFWs to empower them to exercise their rights. In 2017, consultations facilitated by the Federal Government with key stakeholders and partners involved in the protection of TFWs identified a clear need for collaborative engagement on the issue of TFW protections.

MARCH 2020

Due to the COVID-19 pandemic, Network meetings scheduled for March 2020 and future months are postponed until further notice.

APRIL 2020 The Migrant Worker Support Network Pilot in British Columbia is extended for an additional year, which includes an extension of funding. The extension enables the Network to continue to gather lessons learned and best practices in providing better supports and information to migrant workers. Projects are refocused to respond to the specific needs of migrant workers, as well as the organizations that support them, during the COVID-19 pandemic. In the absence of Network meetings, members continue to communicate regularly with one another to address new or ongoing worker protection issues.

FALL 2020 During Fall 2020, Employment and Social Development Canada plans to assess the best practices and lessons learned from the pilot's activities up until March 2020. The Department is also currently exploring what a long-term, sustainable approach to migrant worker support and protection could look like beyond March 2021.



As part of the project "Building Capacity to Support Migrant Workers in BC", last fall AMSSA held, for the first time, three migrant worker-focused regional meetings in the cities of Prince George, Kelowna and Nanaimo. At these meetings, service providers, employers, migrant worker organizations and volunteers came together to share information on regional priorities and gaps in relation to the support of migrant workers as well as to voice their concerns and challenges related to the Temporary Foreign Worker Program (TFWP). At the same time, these events provided a space for all individuals and organizations supporting migrant workers to connect, share best practices, network and receive professional development training from experts to enhance their capacity in supporting migrant workers.

The recommendations gathered from participants at these events were the foundation for planning and identifying the topics to cover in this year's Regional Meeting agenda.






THE REGIONAL MEETING WILL BE CONDUCTED USING A VIRTUAL EVENTS PLATFORM CALLED ACCELEVENTS.

REGISTER AS AN ATTENDEE

Access the event page on your browser here.

- Click the button that says "Register"
- Select the Free Admission ticket and click Continue
- Enter the required personal information then click Continue
- Click Close to complete your check out
- You should receive an email confirmation




SELECT THE SESSIONS YOU WANT TO ATTEND

After registration, you'll be taken back to the event site, when you scroll below, you should see the list of all sessions that you can join including presentations, speed networking sessions, panel discussions, and breakout sessions.

- Though this is not a required step, you can pre-select the sessions that you want to attend by clicking the "Register" button next to each of the session titles.
- The benefit in pre-selecting the sessions you would like to attend is that this way the platform would create a personalized agenda for you which you will be able to access once you enter the event on the day of the meeting (to access your personalized agenda click sessions -> my sessions)

(Please note that you will still be able to see and attend other sessions as well under the main meeting agenda)




ON THE DAY OF THE MEETING, ENTER THE EVENT PLATFORM

Access the event page on your browser. You can check the confirmation email that is sent to you and click the View Event Details button to be redirected to the event page.

- Click the Enter button to enter the virtual event hub. The button should be visible 30 minutes before the start of the first session.
- Enter the email address you used to register and enter your password, then click Submit. If it's your first time to log in, just create a password. You should be redirected to the virtual event hub.

Note: If after logging in, it does not redirect you to the virtual event hub, just click the Enter Event button again.



Once you've entered the events page, the main page you see (called the Lobby) features a tab called Agenda, under this tab you can see the agenda for this meeting, as well as times and links to join the particular sessions.

On the left side panel you will see tabs listed that include: stage (for viewing presentations hosted on the main stage), sessions (for viewing presentations not hosted on the main stage, panel discussions, and workshop discussions), networking (for participating in speed networking sessions) and expo (for viewing exhibitor booths).

If you have pre-selected the events you want to attend, you can find your personalized agenda under sessions-> my sessions. If you have not pre-selected the events you can use the side panel to view and attend events, or as mentioned, you can also use the agenda in the lobby of the events page.

At the time of the scheduled session click join, next to the session listing and this will take you to the particular session.

Annette is the president of VFCCA (VFCCA) Victoria Filipino Canadian Caregivers, TFW's and Migrant Workers Association, serving from 2007 to present. She also serves on the Board of Directors of Victoria Filipino Canadian Associations (VFCA), Board of directors of Victoria Filipino Seniors Association (VFCSA), Board of Directors of Bayanihan Cultural Housing Society (BCHS) and Representative of the United Filipino Association of British Columbia (UFCABC).

From 2008 to the present, she organizes trainings and workshops such as Food Safe, First Aid, ESL, Hospital Housekeeping, Nursing Upgrading, Career Planning, Human Trafficking and Human Rights, Labour Abuse, Immigration Forum and Information. Annette has helped migrant workers who are in distress from their employers, threatened to be sent home, abused and forced to work long hours without pay. She has offered her home as a shelter if they don't have place to stay and goes above and beyond to support migrant workers in all aspects.


BETH MASCHMANNTSSU at Simon Fraser University





COMMUNITY AIRPORT NEWCOMERS NETWORK (CANN)

Since 1992, S.U.C.C.E.S.S. has been the service provider of port-of-entry/arrival services for newcomers at Vancouver International Airport (YVR) through the Community Airport Newcomers Network (CANN).

CANN began by delivering services to immigrants and resettled refugees with funding from Immigration, Refugees, & Citizenship Canada (IRCC) in 1992, and services were expanded to temporary foreign workers in 2019 with funding from Employment & Social Development Canada (ESDC).

CANN supports newcomers who are landing in Canada via YVR through the following program streams:

- Immigrants (Settlement Program stream funded by IRCC)
- · Resettled Refugees (Resettlement Assistance Program stream funded by IRCC)
- Temporary Foreign Workers (stream funded by ESDC)

Situated in the secure immigration landing room at YVR, CANN operates daily to deliver multi-lingual and culturally appropriate orientation, information, and referrals to clients as they wait for immigration processing with Canada Border Services Agency (CBSA). Service delivery focuses on providing newcomers with localized information to live and work safely in Canada as well as referrals to community and government services.

CANN has served more than 1.1 million clients since the beginning of the program. From April 2019 to March 2020, CANN served 39,741 clients that includes first time landed new immigrants, resettled refugees and Temporary Foreign Workers.


With funding from ESDC, CANN offers TFWs arriving at YVR essential information and orientation about how to live and work safely in Canada, worker's rights, as well as referrals to community and government resources. CANN staff offer information packages as well as verbal orientations in Spanish, French, Punjabi, Hindi, Mandarin and Tagalog, as well as another 16 language as needed.


In addition, CANN staff also provide support to TFWs in addressing matters with CBSA, as well as answering other questions TFWs may have upon arrival. Since the beginning of 2020, CANN staff has also offered TFWs additional information and resources related to health and safety protocols related to COVID-19.

Services are delivered seven days a week from 8am-8pm with extended service hours based on flight arrival patterns. For example, services have been offered as early as 5:00am and as late as 12:00am midnight to support TFW flight arrivals. CANN has served 15,450 Temporary Foreign Workers since 2019 Feb that includes 11,609 SAWP workers till end of December 2020.




