#### **Innovation**

VUEWorks projects, processes or programs that demonstrate new techniques or innovative approaches to asset management best practice at any or all of its life cycle stages. This ward will be given to the organization that has shown great ingenuity in managing their assets using technology and tools. This award will recognize creative use of the VUEWorks module(s) to accomplish company and industry goals.

#### Cost Risk Performance – Return on Investment

Projects or programs demonstrating the balance between the elements of cost, risk and performance to obtain a valuable solution for an asset. This ward will be given to the organization that has demonstrated the use of their asset management program to manage costs and risks to improve overall performance and realize a return on their asset management investment. The ROI can be measured in actual dollar savings, resource efficiencies and/or time savings.

### **Best Practices - Standards**

Organizations or projects that demonstrate the use of good data governance, best practice initiatives and implementation of standards around asset management will be great candidates for this ward. This ward will be given to the organization that has demonstrated strong asset management maturity in the areas of naming standards, SOPs, asset lifecycle documentation and reporting as well as asset condition management.

## **Environment or Community Impact**

Projects which demonstrate a solution to an identified community need which was solved using asset management principles and the VUEWorks Asset Management solution. This award will consider the impact on citizens and the community involved, environmental factors and profit or value derived to the community service or organization.

**Note:** Applicants may apply for an award from each of the above (4) categories. Awarding in each category will be at the discretion of the Judging Panel.
