Highlights Company buying ConocoPhillips Colorado Area assets located outside Weld County Denver – Crestone Peak Resources has agreed to pay ConocoPhillips nearly \$400 million for Colorado’s assets, nearly tripling its Denver-Julesburg area as the company pins on nearly 100,000 acres located in Adams and Arapahoe counties. Sign Up Now Crestone Peak struck a deal to buy 97,000 acres of oil and gas lease rights in Adams and Arapahoe counties and in the city of Aurora, nearly tripling the size of the company in the southern DJ Basin, for about \$380 million. The deal is expected to close by the end of the month. An annual earnings report for 2019 filed by ConocoPhillips revealed the value of the deal. Some common adjustments are possible before setting the final amount, the company noted. The sale covers all of ConocoPhillips’ holdings in the Niobrara shale game in northeastern Colorado. Niobrara is the main geological formation targeting the Denver-Julesburg Basin. The area also includes the extent of mineral rights in the Lowry Mountain Range, a former military bombing series, and drilling areas within the boundaries of aurora city that allows up to 310 wells. The transaction includes some land in the northern counties of Douglas and Elbert as well. Unlike many operators in the DJ Basin, Crestone Peak has primarily targeted suburban areas north of Denver, such as Broomfield, Lafayette, Erie and Frederick rather than Weld County, a slightly more rural location, which dominates production in the basin. For example, Weld County produces more than 2 Bcf/d of natural gas and nearly 600,000 b/d of crude, according to S&P Global Platts Analytics. In comparison, Adams and Arapahoe counties combined to produce 31 MMcf/d, according to the latest data from Colorado Petroleum and Gas Conservation Commission. Despite a much lower number of wells being drilled and completed, average wells in Adams and Arapahoe counties produce initial oil and gas production rates at the same level or stronger than wells in Weld County, according to Platts Analysis. However, operators also sometimes face tougher local opposition to drilling outside Weld County. After the Colorado Legislature passed Senate Bill 181 last year, which gave counties and municipalities more in approving drilling sites, Adams County was one of the first to strengthen regulations. In September, the county created stricter permit applications for drilling within 1,000 feet of a home or school. State law requires special permission to drill within 500 feet of a home and 1,000 feet of a school. Meanwhile, Boulder County, Berthoud, Broomfield, Erie, Lafayette, Longmont, Superior and Timnath have all passed drilling moratoriums, such as draft new or updated drilling regulations. However, most of these time limits are set to expire this year. Also, due to a court order, counties and municipalities are not allowed to prohibit drilling indefinitely. The Colorado Supreme Court’s 2016 ruling that halted local bans found that the state had a vested interest in oil and gas development. Still, the decision does not prevent local governments from pursuing stricter regulations, as the city of Broomfield is currently mulling 2,000-foot drilling setbacks from homes and schools.
