2025 is the Year to Make Your Impact

Beginning in 2026, new IRS rules will limit charitable deductions and add restrictions. You still have the chance to maximize your generosity: higher IRA rollover limits, more favorable rules for deductions, and new opportunities to combine giving and income planning.

Make a Bequest

Designate Venice Family Clinic as a beneficiary of your estate without reducing any of your assets during your lifetime and also lowering the tax burden for loved ones.

- As a percent of your estate or as an outright gift in your will or trust
- Real estate (residence or land)
- Retirement assets (e.g., IRA, 401K)
- Life insurance policy
- Bank and brokerage accounts

BEQUEST LANGUAGE

Your estate planning team can use the following language in your will or trust or to make an amendment or add a codicil to your plans.

I, <u>NAME</u> give <u>INSERT DESCRIPTION OF ASSET</u> to Venice Family Clinic Foundation, a 501(c)3 nonprofit organization Tax ID 27-3484548, 604 Rose Ave., Venice, CA 90291 to be used for <u>UNRESTRICTED SUPPORT OR NAME OF SPECIFIC PROGRAM.</u>*

*If circumstances arise in the future that make the purpose of the gift impossible, impractical, or obsolete, then the Board of Directors of Venice Family Clinic may authorize the reallocation of the gift to a purpose as near as possible to the intent of the original bequest.

Ways to Give a Gift Now

- IRA Charitable Distribution Starting at age 70 1/2, you can give a gift of up to \$108,000 directly from your IRA to Venice Family Clinic. If you're 73 or older, it satisfies your required minimum distribution (RMD) while reducing your taxable income. Also, because it isn't included in your IRS charitable deduction limits, it allows you to maximize your giving.
- Appreciated Securities If you donate securities or similar assets that you have owned for more than one year, you are entitled to a charitable income tax deduction based on their current value and you also may avoid capital gains taxes.
- Donor Advised Funds This gift arrangement may be funded with a variety of assets and will provide an immediate charitable tax income deduction while allowing you and your loved ones to recommend grants.
- Charitable Lead Trust Make an immediate impact and reap tax advantages.
 When this trust ends, the remaining assets are distributed to your family or other loved ones.

Ways to Give a Future Gift

- Bequest Designate the Clinic in your will or trust and this may reduce the tax burden for your loved ones after you are gone.
- Retained Life Estate Donate a residence and continue to live there for life and receive an immediate charitable income tax deduction.
- Charitable Remainder Trust Make a future gift that generates predictable income for life or for a term of years for you and a loved one. Receive an immediate charitable income tax deduction, pay no capital gains tax at the time you transfer assets to the trust, and remove the assets from your taxable estate. May be funded in 2025 with a one-time \$54,000 IRA rollover.
- Charitable Gift Annuity Establish this annuity to give a future gift and receive fixed lifetime income for you and a loved one while realizing tax benefits. May be funded in 2025 with a one-time \$54,000 IRA rollover.
