## GDPR Information

What information we collect from users: cookie information about your visit and your email if you complete any optin forms on our site.

When we collect information from users: when you visit our website or sign up via an optin form.

Protection of that information: all information is securely stored and only accessible to relevant staff members in the execution of their tasks.

What we do with that information: we use cookies to enhance your visit, remember if you are logged in and to collect visit analytics.

## General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

IKKONIK LTD legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

- IKKONIK LTD needs to perform a contract with you
- You have given IKKONIK LTD permission to do so
- Processing your personal information is in IKKONIK LTD legitimate interests
- IKKONIK LTD needs to comply with the law

IKKONIK LTD will retain your personal information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our policies.

If you are a resident of the European Economic Area (EEA), you have certain data protection rights. If you wish to be informed what Personal Information we hold about you and if you want it to be removed from our systems, please contact us.

In certain circumstances, you have the following data protection rights:

- The right to access, update or to delete the information we have on you.

## **Log Files**

Ikkonik follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

## **Cookies and Web Beacons**

Like any other website, Ikkonik uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

## **Facebook / Google Remarketing**

Third parties, including Facebook & Google, may use cookies, web beacons, and other storage technologies to collect or receive information

from our website and elsewhere on the internet, and use that information to provide measurement services and target ads. With Facebook & Google remarketing you may see our ads on Facebook or on Google channels after you have visited our site. For this to happen, Facebook & Google use a Custom Audience Pixel that is activated when a visitor lands on a webpage and a unique “cookie” is placed in their browser. Facebook lookalike audience targeting allows us to show ads on Facebook to people who are similar to those who have already visited or made a purchase from our website.
