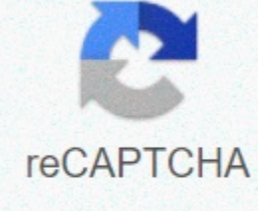

For example, if the corporation was established in April 2016, the due date for Illinois' annual report each year would be March 31, 2016. Illinois' annual report can be filed online when companies agree to pay a \$50 fee. However, there are some cases when applying online. Domestic and foreign corporations have different requirements of the annual report form. There is a late fee estimated for the late filing of Illinois' annual reports. LLCs pay \$300 if payment is delayed by 60 days. Corporations pay a fee based on annual franchise tax. The company cannot change its Illinois-registered agent on its annual report form.
