

## **Sweet Cherry Case Pick Drawing Rules**

July 1 - 30, 2025

## **Promotional Rules**

- 1. Participation in the Sweet Cherry Case Pick Drawing (the "Promotion") is limited to Cherry Rewards members ("Participant(s)").
- 2. Membership in Cherry Rewards does not guarantee entry into this Promotion and participation may be limited at Virgin Hotels Las Vegas ("VHLV") Management's discretion.
- 3. Participants are subject to all terms and conditions of Cherry Rewards membership as outlined in the Cherry Rewards rules at https://virginhotels.com/casino/cherryrewards/.
- 4. Membership in Cherry Rewards is available to qualified persons age 21 and over, and membership is free.
- 5. No entry fee is required to participate in this Promotion.
- 6. Participants can earn one (1) Drawing Ticket for every hundred (100) Base Rewards Points from 12:00 am, July 1 through 6:55 pm, July 30. Drawing Tickets may be activated at any slot machine.
- 7. Drawings will be conducted every Wednesday in July at 7:00 pm. Five (5) Participants will be chosen from the electronic drawing program to either take a guaranteed \$500 in Free Slot Play or choose one of six cases containing as low as \$100 in Free Slot Play or up to \$2,500 in Free Slot Play.
- 8. Three (3) cases will contain Free Slot Play Prizes lower in value than \$500 in Free Slot Play and three (3) cases will contain Free Slot Play Prizes higher in value than \$500 in Free Slot Play. After the first Winner chooses a Free Slot Play Prize from the case, the prizes inside all six cases will be refilled and shuffled.
- 9. Winners will be announced at the Promotion Desk next to Hotel Registration. Winners will have three (3) minutes from being announced to present themselves at the drawing area to choose their Prize. If a Participant does not show up within the allotted time, another name will be called in their place.
- 10. Winners must be present for the Drawing to choose their Prize.
- 11. Participants will enter their Drawing Tickets through the following steps:
  - a. Press Menu on the slot machine screen
  - b. Press Drawing
  - c. Press Sweet Cherry Case Pick Drawing
  - d. Press the **Drawing Date** and choose one of the following:
    - i. Enter All Enter all available Drawing Tickets into the chosen drawing
    - ii. **Enter Some** Enter a specified number of available Drawing Tickets into the chosen drawing
    - iii. **Start Auto Entry** Enter any Drawing Tickets into the chosen drawing as soon as they are earned
  - e. Press Confirm
  - f. Press Done
- 12. Participants must check in their Drawing Tickets on the slot machine from 6:00 pm to 6:55 pm on the Drawing Date for their Drawing Tickets to be pulled. Participants can check in their Drawing Tickets through the following steps:
  - a. Press Menu on the slot machine
  - b. Press **Drawings**
  - c. The **Check In All** option will show when it is time to check into the Drawing. Press **Check In All** to check into the upcoming Drawing.
- 13. There is no limit to the number of Drawing Tickets that may be earned/entered.
- 14. Any Drawing Tickets that aren't selected in the Drawing will still have a chance to be pulled in a future Sweet Cherry Case Pick Drawing in July.
- 15. The Participants' Cherry Rewards Card must be inserted in the slot machine while playing to earn Rewards Points.
- 16. Drawing Tickets are non-transferable.
- 17. A Participant may only win one (1) Prize per week.
- 18. Free Slot Play won from the Promotion will be valid for seven (7) days.
- 19. If for any reason the Promotion is not capable of running as planned by VHLV casino marketing, including without limitation infection by computer virus, corrupted hardware or software, tampering, unauthorized
