

Walk In and Win Slot Tournament Rules

December 3, 10, 15, 22, 2025

Promotional Rules

- 1. Participation in the Walk In and Win Slot Tournament (the "Tournament" and/or "Promotion") is open to all Cherry Rewards members ("Participant(s)").
- 2. Membership in Cherry Rewards does not guarantee entry into this Tournament and participation may be limited at Virgin Hotels Las Vegas ("VHLV") Management's discretion.
- 3. Participants are subject to all terms and conditions of Cherry Rewards membership as outlined in the Cherry Rewards rules at https://virginhotels.com/casino/cherry-rewards/.
- 4. Membership in Cherry Rewards is available to qualified persons age 21 and over, and membership is free.
- 5. No entry fee is required to participate in this Promotion.
- 6. Participants can earn one (1) entry into the round of the Slot Tournament for every two hundred (200) same day Rewards Points. Earning period is from 12:00 am 6:59 pm every Tournament Day in December.
- 7. There is a max of two (2) entries that may be played per Tournament Day with the exception of December 22. On December 22, three (3) entries may be played with the mention code from the 6 Days of Gifts Promotion.
- 8. Each Tournament's Day's Prize Structure is based on a minimum of fifty (50) Participants. There is no limit on the maximum number of Participants per Promotion Day.
- 9. The first place Winners of each Tournament Day in December (4 Total) will receive \$1,000 in Free Slot Play along with complimentary entry into the \$60k Triple Stakes Slot Tournament from January 15 17, 2026. The Casino Marketing Team will reach out to the first place Winners to confirm reservation into the \$60k Triple Stakes Slot Tournament. The Winners will also receive complimentary room nights for January 14 17, 2026. A hotel stay is required for any guest without a NV license.
- 10. A Participant can win first place more than once throughout the month but will only receive one (1) entry into the \$60k Triple Stakes Slot Tournament.
- 11. Rewards Points towards Tournament Entries are calculated from live slots, video poker, and/or table games. Rewards Points earned from non-gaming will not count towards the calculation.
- 12. Participants must register and play their Tournament entries between 3:00 pm and 7:00 pm of each Tournament Day.
- 13. Participants must be in the Tournament line no later than 6:59 pm of each Tournament Day.
- 14. Participants must have their Cherry Rewards card to activate the Tournament play.
- 15. No money, tokens, or coins will be required to play the Tournament slot machines.
- 16. All scores will be automatically recorded on a credit meter of each machine. It is each Participant's responsibility to verify their score obtained in the round prior to leaving the Tournament area. Upon a Participant leaving the Tournament slot machine assigned, the Participant's automatically recorded score shall be deemed final and accurate.
- 17. The Participants' top score of their possible two (2) scores (possible three (3) scores on December 22) per Tournament Day will determine the overall order of finish for the Tournament.
- 18. In the event of a tie, the tied Participants will equally split the sum total of the applicable prizes.
- 19. The Tournament Status, Winners, and Rankings will be posted at the Casino Cage following the conclusion of each Tournament Day.
- 20. All Prizes will be awarded in Free Slot Play and will be loaded onto the Participant's Players Card within two (2) hours following the conclusion of each Tournament Day.
- 21. All Free Slot Play Prizes will be valid for thirty (30) days issuance.
- 22. Participants do not need to be present to redeem their Prize.
- 23. Entries are non-transferrable; however, a Participant may assign a proxy person to participate on their behalf. Proxy person must be 21 years, or older, and such proxy person may participate in the Tournament



- round(s), provided that such a proxy person is in the presence of, and participating at the request and direction of, the Participant. Any prizes won will be awarded to the registered Participant.
- 24. While at all times conforming to these rules addressing eligibility as well as dates and times of play, Participants who are timely present to play in the Tournament will be able to select one available and Tournament-operational slot machine per Tournament round.
- 25. In the event of a machine malfunction, it is the Participant's responsibility to immediately notify the Tournament representative who will move the Participant to a vacant Tournament slot machine to play their round. A complete round must be played on a single slot machine. One (1) single Participant must play an entire round at a single slot machine. The points previously accumulated on any machine that malfunctioned will be voided and will not stand or be carried over to the new round of play that takes place at another Tournament slot machine.
- 26. The Participant must report any machine malfunction immediately upon any such issue occurring so that claims involving malfunction may be considered during the session, and only during the session, of play in progress. In such an event, the Participant must immediately cease playing on any malfunctioning Tournament slot machine, to be followed by playing on another Tournament slot machine assigned by management at management's sole discretion.
- 27. If for any reason the Tournament is not capable of running as planned, including without limitation by computer virus, corrupted hardware or software, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of VHLV Casino Marketing Team which adversely affect the administration, security, fairness, integrity, or proper conduct of this Tournament, VHLV Casino Marketing Team reserves the right in its sole and absolute discretion to cancel, terminate, modify, extend, or suspend the Tournament.
- 28. Malfunction by any device and/or devices voids all plays, pays and prizes. In any such event, VHLV Casino Marketing Team reserves all rights described by these Rules.
