



\$15k Midweek Mania Slot Tournament Rules

March 10, 2026

Tournament Rules

1. Participation in the \$15k Midweek Mania Slot Tournament is open to invited Cherry Rewards members.
2. Membership in Cherry Rewards does not guarantee entry into this Tournament and participation may be limited at Virgin Hotels Las Vegas ("VHLV") Management's discretion.
3. All participants must comply with Cherry Rewards terms and conditions as outlined at Cherry Rewards Rules at <https://virginhotels.com/casino/cherryrewards/>.
4. Cherry Rewards membership is free and available to qualified individuals aged 21 or older.
5. No entry fee is required to participate in this Promotion.
6. Invited Participants will play one (1) Round consisting of two (2) sessions for a chance to win up to \$3,000 in Free Slot Play. Participants may also earn 5,000 Base Cherry Rewards Points to play one (1) bonus round where they will have the opportunity to drop their lowest score.
7. This Promotion is open to Guests who earn two thousand (2,000) base Rewards Points from February 20, 2026, 5:01 am to March 8, 11:59 pm. Guests who earn into the Slot Tournament must register at the Cherry Rewards Desk during the registration times.
8. Participants must play the round in their Session Times given to them at registration.
9. Participants will play their two (2) two (2) minute sessions back-to-back.
10. Participants must register their Tournament Round at the Cherry Rewards Desk on either March 9, 2026 from 6:00 pm to 8:00 pm or March 10, 2026 from 9:00 am to 10:00 am. Tournament session times will be assigned at registration.
11. It is the Participants' responsibility to show up at the assigned time given at registration. If a Participant fails to show up at the assigned time, their score for that session will be void.
12. It is the Participant's responsibility to be seated at the correct seat during their session. The Participants' names will be displayed at the top of the tournament machine.
13. Participants must register their Bonus Round at the Cherry Rewards Desk on March 10, 2026 following the conclusion of the Tournament Play. Bonus Round session times will be assigned at the Cherry Rewards Desk. Bonus Round sessions are two (2) minutes.
14. The earning period to earn the five thousand (5,000) Base Cherry Rewards Points for the Bonus Round will be from 5:01 am, March 9, 2026 through 11:00 am March 10, 2026.
15. The top hundred (100) Participants with the highest score will receive a Free Slot Play Prize.
16. Winners do not need to be present to claim their Prize.
17. The Tournament Status and Ranking will be live updated at the Cherry Rewards Desk. The final results and Winners will be posted at the Casino Cage.
18. All Free Slot Play Prizes will be valid for seven (7) days from issuance.
19. Participants may designate a proxy aged 21 or older to play on their behalf. Participants must be present at the time proxy's delegated play time. Prizes will be awarded to the registered participant.
20. In the event of a machine malfunction, it is the Participant's responsibility to immediately notify the Tournament representative who will move the Participant to a vacant Tournament slot machine to play their round. A complete round must be played on a single slot machine. One (1) single Participant must play an entire round at a single slot machine. The points previously accumulated on any machine that malfunctioned will be voided and will not stand or be carried over to the new round of play that takes place at another Tournament slot machine.
21. The Participant must report any machine malfunction immediately upon any such issue occurring so that claims involving malfunction may be considered during the session, and only during the session, of play in progress. In such an event, the Participant must immediately cease playing on any malfunctioning Tournament slot machine, to be followed by playing on another Tournament slot machine assigned by management at management's sole discretion.
22. No money, tokens or coins will be required to play the Tournament slot machines.
23. All scores will be automatically recorded on a credit meter of each machine. At the end of the 2-minute session, the total score will be recorded on the credit meter. It is each Participant's responsibility to verify their score obtained in the round prior to leaving the Tournament area. Upon a Participant leaving the Tournament slot machine assigned, the Participant's automatically recorded score shall be deemed final and accurate.
24. The Participant's two (2) scores will be accumulated to form their final score for the Tournament. If a Participant qualifies for the Bonus Round, the lowest score will be dropped.
25. Participants will only be rewarded one (1) Prize for the Tournament.
26. In the event of a tie, the tied Participants will equally split the sum total of the applicable Prizes.



27. All prizes will be awarded in Free Slot Play and will be loaded onto the Participant's Cherry Rewards account within two (2) hours after the completion of the Tournament.
28. If for any reason the Tournament is not capable of running as planned, including without limitation by computer virus, corrupted hardware or software, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of VHLV Casino Marketing Team which adversely affect the administration, security, fairness, integrity, or proper conduct of this Tournament, VHLV Casino Marketing Team reserves the right in its sole and absolute discretion to cancel, terminate, modify, extend, or suspend the Tournament.
