



PointMania Rules

March 30 – April 13, 2026

Promotional Rules

1. Participation in PointMania (the “Promotion”) is limited to Cherry Rewards members (“Participant(s)”).
2. Membership in Cherry Rewards does not guarantee entry into this Promotion and participation may be limited at Virgin Hotels Las Vegas (“VHLV”) Management’s discretion.

10. Only one (1) entry may be earned per day, regardless of the number of base points earned.

 - k. Day 11: Earn 1 entry at 100 points (Earned: 11 entries, Multiplier x11 days: 121 Total entries)
 - l. Day 12: Earn 1 entry at 100 points (Earned: 12 entries, Multiplier x12 days: 144 Total entries)
 - m. Day 13: Earn 1 entry at 100 points (Earned: 13 entries, Multiplier x13 days: 169 Total entries)
 - n. Day 14: Earn 1 entry at 100 points (Earned: 14 entries, Multiplier x14 days: 196 Total entries)
 - o. Day 15: Earn 1 entry at 100 points (Earned: 15 entries, Multiplier x15 days: 225 Total entries maximum)
13. Multiplier will be based on how many qualified days are made during earning period
14. Bonus entries are not based on additional points earned within a single day.
15. A maximum of 225 total entries may be earned during the promotional period.
