



Vintage Vibes Senior Day Drawing and 10X Multiplier Rules
Tuesdays in May 2026

Promotional Rules

1. Participation in the Vintage Vibes Senior Day Drawing and 10X Multiplier (the “Promotion”) is limited to Cherry Rewards members 50 years old or older (“Participant(s”).
2. The Promotion will take place every Tuesday in May (May 5, 12, 19, 26, 2026 – “Promotion Day”).
3. Membership in Cherry Rewards does not guarantee entry into this Promotion and participation may be limited at Virgin Hotels Las Vegas (“VHLV”) Management’s discretion.

Vintage Vibes Drawing Rules

9. Participants can earn one (1) Drawing Ticket for every hundred (100) Same Day, Base Rewards Points from 12:00 am through 6:55 pm every Promotion Day.
10. Drawings will be conducted on Tuesdays in May at 7:00 pm. Three (3) Participants will be chosen from the electronic drawing program to win up to \$500 in Free Slot Play.
11. Participants who earn at least one (1) Drawing Ticket every Vintage Vibes Senior Day Promotion Day in May will have all their Drawing Tickets for the month entered to win \$1,000 in Free Slot Play.
12. Participants do not need to be present to win. Winners will be contacted through email if they win. Winners will also be posted in the Casino Cage.
13. There is no limit to the number of Drawing Tickets that may be earned/entered.
14. Drawing Tickets do not carry over to the next Drawing unless the Participant is eligible for the Grand Prize Drawing. If the Participant is eligible for the Grand Prize Drawing, all the Participants’ Drawing Tickets for the month will be entered.

23. The 10X Multiplier will only apply to Rewards Points earned on slot, video poker, and table games play. Any Rewards Points earned through any other methods will not have the 10X Multiplier applied.
24. There is no max on the number of Rewards Points that may be earned during the multiplier period.
25. Rewards Points towards the Promotion are calculated from live slots, video poker, and/or table games. Rewards Points earned from non-gaming will not count towards the drawing ticket calculation.
