



**Cherry Picked Gift Days Giveaway Rules**  
Thursdays and Fridays in June 2026

**Promotional Rules**

1. Participation in the Cherry Picked Gift Days Giveaway (the “Promotion”) is open to all Cherry Rewards members (“Participant(s)”).
2. The Promotion will take place every Thursday and Friday in June (June 4 – 5, 11 – 12, 18 – 19, 25 – 26, 2026 – “Promotion Week”)
3. Membership in Cherry Rewards does not guarantee entry into this Promotion and participation may be limited at Virgin Hotels Las Vegas (“VHLV”) Management’s discretion.

5. Membership in Cherry Rewards is available to qualified persons age 21 and over, and membership is free.

7. Every three hundred (300) base Rewards Points earned from 12:00 am, Thursdays to 8:00 pm, Fridays in June 2026 can be used to redeem one (1) Cherry Picked Gift Day Gift. Invited Guests will receive one (1) complimentary Gift per Promotional Week.
8. Guests can earn 7,777 base, Rewards Points across all Promotional Periods in June to redeem a \$100 Gift Card to either Target, Total Wine, or Home Depot.
9. Gifts may be redeemed at the Cherry Rewards Desk Thursdays and Fridays in June 2026 from 3:00 pm – 8:00 pm.

12. There is a maximum of one (1) Gift Card that may be redeemed for the month.
13. For the Gift Card, a guest must confirm they qualify for the Gift Card at the Cherry Rewards Desk during the redemption period. The Guest will receive a slip confirming they are qualified and bring to the Casino Cage to redeem their Gift Card.
14. Invited Guests that receive a Complimentary Gift may earn three hundred (300) Rewards Points to redeem an additional Gift.
15. Participants’ Rewards Points will not decrease from redeeming their Gift(s). Participants will keep their Rewards Points.
16. Rewards Points towards the Promotion are calculated from live slots, video poker, and/or table games. Rewards Points earned from multipliers and non-gaming will not count towards the calculation.
17. Gifts are distributed while supplies last.
