



## Walk In & Win Slot Tournaments Rules

Wednesdays in July 2026

### Tournament Rules

1. Participation in the Walk In & Win Slot Tournaments (the "Tournament" and/or "Promotion") is open to invited Cherry Rewards members ("Participant(s)").
2. The Promotion will take place every Wednesday in July (July 1, 8, 15, 22, 29, 2026 – "Promotion Day and/or Tournament Day").
3. Membership in Cherry Rewards does not guarantee entry into this Tournament and participation may be limited at Virgin Hotels Las Vegas ("VHLV") Management's discretion.
4. Participants are subject to all terms and conditions of Cherry Rewards membership as outlined in the Cherry Rewards rules at <https://virginhotels.com/casino/cherryrewards/>.
5. Membership in Cherry Rewards is available to qualified persons age 21 and over, and membership is free.
6. No entry fee is required to participate in this Promotion.
7. Participants can earn one (1) round into the Slot Tournament for every two hundred (200) same day, base Rewards Points. Ten (10) Participants will win up to \$2,500 in Free Slot Play each Tournament Day.
8. Rewards Points towards the tournament are calculated from live slots, video poker, and/or table games. Rewards Points earned from multipliers and non-gaming will not count towards the calculation.
9. The earning period to earn one (1) round in the Slot Tournament is from 12:00 am to 6:59 pm each Tournament Day.
10. There is a max of five (5) rounds that may be earned on each Tournament Day.
11. Participants must register their Tournament Round at the Cherry Rewards Desk from 3:00 pm – 7:00 pm each Tournament Day. Tournament rounds will be two (2) minutes each.
12. The ten (10) Participants with the highest scores of each Tournament Day will receive a Free Slot Play Prize.
13. Winners do not need to be present to claim their Prize.
14. The Tournament Status and Ranking will be live updated at the Tournament Play Area across from the Cherry Rewards Desk. The final results and Winners will be available at the Casino Cage following the conclusion of the Tournament.
15. All Free Slot Play Prizes will be valid for seven (7) days from issuance. All Prizes will be added to the Winners' cards within two (2) hours following the conclusion of the Tournament.
16. The last session of each Tournament Day will start at 7:00 pm. There will be no sessions played after 7:00 pm. It is the Participants' responsibility to play their earned session(s) by 7:00 pm.
17. Participants cannot choose their seat. Before the start of each session, the seats will be randomized through the randomization feature in the tournament software.
18. A Participant may assign a proxy person to participate on their behalf. Proxy person must be 21 years, or older, and such proxy person may participate in the Tournament round(s), provided that such a proxy person is in the presence of, and participating at the request and direction of, the Participant. Any prizes won will be awarded to the registered Participant.
19. While at all times conforming to these rules addressing eligibility as well as dates and times of play, Participants who are timely present to play in the Tournament will be assigned one available and Tournament-operational slot machine per Tournament round.
20. In the event of a machine malfunction, it is the Participant's responsibility to immediately notify the Tournament representative who will move the Participant to a vacant Tournament slot machine to play their round. A complete round must be played on a single slot machine. One (1) single Participant must play an entire round at a single slot machine. The points previously accumulated on any machine that malfunctioned will be voided and will not stand or be carried over to the new round of play that takes place at another Tournament slot machine.
21. The Participant must report any machine malfunction immediately upon any such issue occurring so that claims involving malfunction may be considered during the session, and only during the session, of play in progress. In such an event, the Participant must immediately cease playing on any malfunctioning Tournament slot machine, to be followed by playing on another Tournament slot machine assigned by management at management's sole discretion.
22. No money, tokens or coins will be required to play the Tournament slot machines.
23. All scores will be automatically recorded on a credit meter of each machine. At the end of the 2-minute session, the total score will be recorded on the credit meter. It is each Participant's responsibility to verify their score obtained in the round prior to leaving the Tournament area. Upon a Participant leaving the Tournament slot machine assigned, the Participant's automatically recorded score shall be deemed final and accurate.
24. The Participants' top score of their possible five (5) rounds per Tournament Day will determine the overall order of finish for the Tournament.



25. Participants will only be rewarded one (1) Prize for the Tournament.
26. In the event of a tie, the tied Participants will equally split the sum total of the applicable Prizes.
27. If for any reason the Tournament is not capable of running as planned, including without limitation by computer virus, corrupted hardware or software, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of VHLV Casino Marketing Team which adversely affect the administration, security, fairness, integrity, or proper conduct of this Tournament, VHLV Casino Marketing Team reserves the right in its sole and absolute discretion to cancel, terminate, modify, extend, or suspend the Tournament.
28. Malfunction by any device and/or devices voids all plays, pays and prizes. In any such event, VHLV Casino Marketing Team reserves all rights described by these Rules.
29. There will be no smoking allowed in the Tournament Area.
30. The Tournament Prize Structure is based on a minimum of ten (10) Participants. The Tournament Prize Structure is as follows:
