

Terms of Service

1. Introduction

Welcome to Voxqube operated by Voxqube GmbH (“Company”, “we”, “our”, “us”).

These Terms of Service (“Terms”, “Terms of Service”) govern your use of our web pages located at www.voxqube.com and operated by Voxqube GmbH.

2. Communications

By creating an Account on our Service, you agree to subscribe to newsletters, marketing or promotional materials and other information we may send. 3. Purchases

We reserve the right to refuse or cancel your order if fraud or an unauthorized or illegal transaction is suspected.

5. Project Quotation & Subscriptions

Some parts of Service might be billed either on a project quotation or on a subscription basis ("Subscription(s)"). In case of project quotation model, you will be billed as a one-off payment according to a project quote set by the company. In case of subscription model, you will be billed in advance on a recurring and periodic basis ("Billing Cycle"). Billing cycles are set either on a monthly or annual basis, depending on the type of subscription plan you select when purchasing a Subscription.

At the end of each Billing Cycle, your Subscription will automatically renew under the exact same conditions unless you cancel it or Voxqube GmbH cancels it. You may cancel your Subscription renewal either through your online account management page or by contacting customer support team.

A valid payment method, including credit card, is required to process the payment for your subscription. You shall provide Voxqube GmbH with accurate and complete billing information including full name, address, state, zip code, telephone number, and a valid payment method information. By submitting such payment information, you automatically authorize Voxqube GmbH to charge all Subscription fees incurred through your account to any such payment instruments.

Should automatic billing fail to occur for any reason, Voxqube GmbH will issue an electronic invoice indicating that you must proceed manually, within a certain deadline date, with the full payment corresponding to the billing period as indicated on the invoice.

6. Fee Changes

Voxqube GmbH, in its sole discretion and at any time, may modify Subscription fees for the Subscriptions. Any Subscription fee change will become effective at the end of the then-current Billing Cycle.

Voxqube GmbH will provide you with a reasonable prior notice of any change in Subscription fees to give you an opportunity to terminate your Subscription before such change becomes effective.

Your continued use of Service after Subscription fee change comes into effect constitutes your agreement to pay the modified Subscription fee amount.

7. Refunds

We issue refunds for Contracts within seven (7) business days of the original purchase of the Contract.

8. Content
