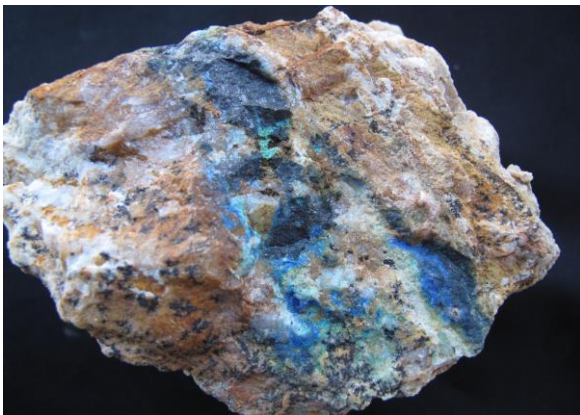

SUMMARY

August 2018

- **Vancouver-based:** Continuation of 4 years of active copper exploration in Nevada by private company.
- **Track Record:** Proven track record of Board in exploration, discovery and M&A; **Innovation & Focus.**
- **Junction (Cu-Ag) Project:** Surface exploration continues on 6 km vein/dyke trend; **drilling planned for fall 2018.**
- **Bonita (Cu) Project:** Four years of continuous exploration to discover & delineate alkaline porphyry Cu-Au system; First pass drilling in Nov. 2017, followed by 1,900 m in June, 2018; **surface work ongoing.**
- **Danbo (Au) Project:** New acquisition expands Danbo from property-scale to district-scale Tertiary gold play.
- **Property Attributes:** 100% Ownership = market leverage; local infrastructure = cost effective exploration.

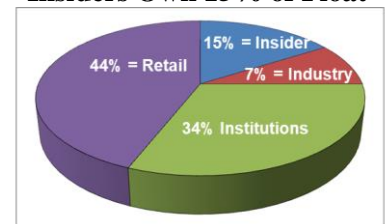
The Executive team has a strong and active track record for capturing shareholder value through discovery and sale of world class deposits. Directors include:

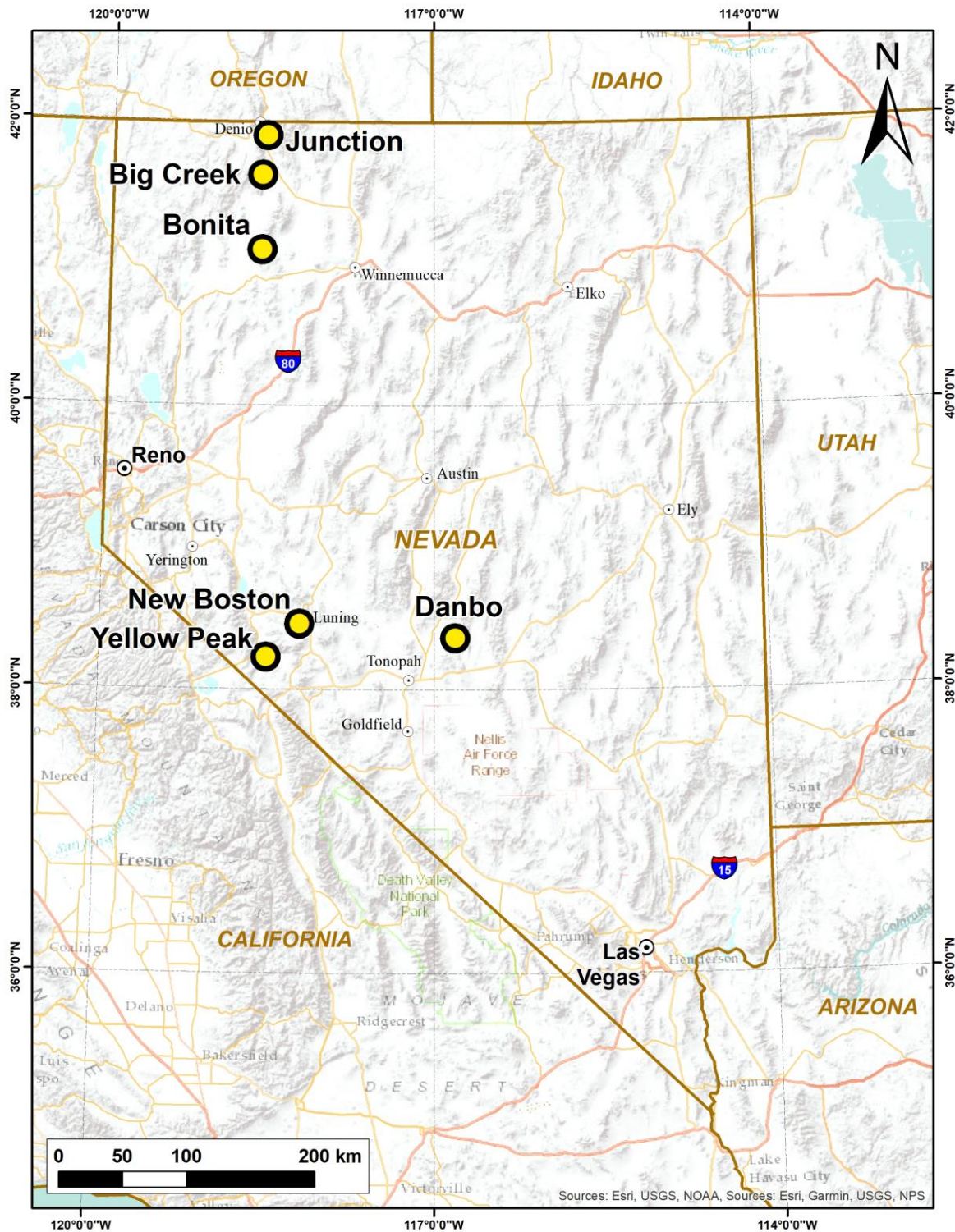
