

BUDWEISER & BUD LIGHT HOME RUN GETAWAY CONTEST (the “Contest”)

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. SPONSOR: The sponsor of this Contest is Labatt Brewing Company Limited, 207 Queens Quay West, Suite 299, Toronto, Ontario M5J 1A7 (“**Sponsor**”).

2. ELIGIBILITY:

- (a) The Contest is open only to residents of Ontario who are at least twenty-one (21) years of age at the time of entry.
- (b) The following individuals and their household members (whether or not related) are not eligible to enter the Contest: employees, officers, directors, shareholders, agents, representatives, successors and assigns of each of (i) Sponsor, (ii) Rogers Blue Jays Baseball Partnership (“**RBJBP**”), owner of the *Toronto Blue Jays*™ Major League Baseball team (the “**Team**”), (iii) the MLB Entities (defined below), (iv) each of their respective parents, affiliated companies, and subsidiaries, and (v) any and all other companies associated with the Contest. The “**MLB Entities**” shall mean the Office of the Commissioner of Baseball (the “**BOC**”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“**MLBAM**”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (the “**Clubs**”), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.
- (c) Sponsor and RBJBP shall have the right at any time to require proof of identity and/or eligibility to enter the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Sponsor and RBJBP reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

3. HOW TO ENTER:

- (a) The Contest entry period begins at 10:00 a.m. Eastern Time (“**ET**”) on Monday, June 22, 2026 and ends at 11:59 p.m. ET on Sunday, November 1, 2026 (the “**Entry Period**”).
- (b) There are two (2) ways to enter: (1) by entering a PIN code; or (2) via email. No other method of entry will be accepted.
 - (i) **Via bluejays.com by Entering a PIN Code.** During the Entry Period, entrants can find a PIN code inside specially marked packages of any Participating Product (as defined below), available only at participating retailers and while supplies last. During the Entry Period, go to www.bluejays.com/BudxBudLightHomeRunContest to access the online entry form for the Contest (the “**Entry Form**”), complete the Entry Form as instructed, including all required information, correctly enter your PIN code on the Entry Form, and submit the completed Entry Form for one (1) entry into the Contest (the “**PIN Code Entry**”).
 - (ii) **No Purchase Email Method:** An entrant may enter the Contest without a PIN code by sending an email to tbjcontest@bluejays.com that (A) has as its subject line “Budweiser & Bud Light Home Run Getaway Contest – Initial Entry”, (B) includes a maximum fifty (50) word

description stating why they would like to win the Contest, and (C) specifies the entrant's full name, address, city, province, postal code, age and day and evening telephone numbers (the "**Initial Email Entry**"). An Initial Email Entry must be received by RBJBP by no later than 11:59 PM on Sunday, November 1, 2026. The literary quality of the maximum fifty (50) word submission will not be judged or otherwise used in any way in, and will have no effect on, the determination of the winners.

Pin Code Entries and Initial Email Entries will be referred to herein collectively as "**Initial Entries**". There is a limit of one (1) Initial Entry per eligible entrant per day, regardless of which method of obtaining Initial Entries is chosen.

- (c) There are two (2) ways in which an entrant may obtain five (5) additional entries into the Contest: (1) via opt-in; or (2) by email. No other method of obtaining additional entries will be accepted.
- (i) **Via Opt-In:** An entrant will receive five (5) additional entries in this Contest upon submission of their PIN Code Entry if, while completing the Entry Form, they opt-in to receive electronic commercial messages from Sponsor, including information, promotions, and offers, by clicking the corresponding box (the "**Opt-In Entry**").

OR

- (ii) **By Email:** An entrant will receive five (5) additional entries in this Contest if, upon submission of their PIN Code Entry or their Initial Email Entry, they send an email to tbjcontest@bluejays.com that (A) has as its subject line "Budweiser & Bud Light Home Run Getaway Contest – Additional Entry", (B) includes a maximum fifty (50) word description stating what the Team means to them, and (C) specifies the entrant's full name, address, city, province, postal code, age and day and evening telephone numbers (such information to be identical to the information supplied by the entrant in their PIN Code Entry or their Initial Email Entry) (the "**Additional Email Entry**"). An Additional Email Entry must be received by RBJBP by no later than 11:59 PM on Sunday, November 1, 2026. The literary quality of the maximum fifty (50) word submission will not be judged or otherwise used in any way in, and will have no effect on, the determination of the winners.

Opt-In Entries and Additional Email Entries will be referred to herein collectively as "**Additional Entries**". There is a limit of five (5) Additional Entries per eligible entrant during the Entry Period, regardless of which method of obtaining Additional Entries is chosen.

Initial Entries and Additional Entries will be referred to herein collectively as "**Entries**".

For the purpose of these Official Rules:

A "**Participating Product**" means any Budweiser or Bud Light product for which the packaging is specially marked to denote that there is a PIN code inside, sold by a retailer of such product in Canada.

- (d) MLBAM's computer shall be the official clock of the Contest with respect to Entries submitted online. Free access to the Internet is available at most public libraries. Entrants are solely responsible for Internet connectivity, software and/or hardware that may be required in order to create and/or submit any Entry.
- (e) By entering this Contest, each entrant consents to the collection, use, and disclosure of their personal information for the purposes and in the manner described herein. All information submitted by entrants on bluejays.com is being collected by MLBAM and is subject to, and will be treated in a manner consistent with, MLBAM's Terms of Use accessible at: mlb.com/tou and Privacy Policy accessible at: mlb.com/privacy. Information submitted by entrants on bluejays.com will be provided to RBJBP and treated in accordance with RBJBP's Privacy Policy available at

www.bluejays.com/privacy, subject to the entrants' stated preferences from time to time. Limited information submitted by entrants on bluejays.com in connection with the Contest may be provided to the Sponsor, such as email addresses of those entrants who have opted in to receive commercial electronic messages (such as emails) from Sponsor or contact information that will be used to facilitate prize delivery may be provided to Sponsor, and will be treated in accordance with Sponsor's Privacy Policy available at <https://www.labatt.com/en/privacy-policy>, subject to the entrants' stated preferences from time to time. Online entrants may be given the option to receive commercial electronic messages (e.g., emails) and/or other communications from MLBAM, RBJBP, and/or Sponsor; however, eligibility to participate in the Contest is not dependent upon an entrant's consent to receive such messages and communications and consenting to receive such messages and communications will not impact an entrant's chances of winning. All information submitted by entrants via email is being collected by RBJBP, and will be treated in accordance with RBJBP's Privacy Policy, available at www.bluejays.com/privacy, subject to the entrants' stated preferences from time to time. Limited information submitted by entrants via email, such as contact information that will be used to facilitate prize delivery may be provided to Sponsor, will be treated in accordance with Sponsor's Privacy Policy available at <https://www.labatt.com/en/privacy-policy>, subject to the entrants' stated preferences from time to time.

- (f) All information submitted by entrants offline is being collected by RBJBP or Sponsor and will be available to both parties. All such information will be treated by Sponsor in accordance with Sponsor's Privacy Policy available at <https://www.labatt.com/en/privacy-policy> and by RBJBP in accordance with RBJBP's Privacy Policy, available at www.bluejays.com/privacy. Sponsor's and RBJBP's treatment of information is subject to each entrant's stated preferences from time to time.

4. PRIZE DESCRIPTION:

One (1) grand prize will be awarded, consisting of:

- (a) Two (2) admission tickets (total) for the winner and one (1) guest (collectively, the "**Prize Participants**") to attend two (2) of the Team's regular season baseball games scheduled during the 2027 regular season (the "**Games**"), in a location within North America (the "**Destination**") and on dates to be determined by the winner in consultation with the Sponsor, subject to MLB scheduling and availability. The Games must be on consecutive dates and at the same Destination. Ticket location to the Games will be determined by the Sponsor in its sole discretion;
- (b) One (1) hotel room (standard double occupancy) for three (3) nights in the Destination in a hotel and on dates to be determined by Sponsor in its sole discretion (the "**Hotel**");
- (c) Round trip economy air transportation for the Prize Participants from the international airport within Canada closest to the winner's residence with a direct flight to the Destination (as determined in the sole discretion of Sponsor) to the Destination, on travel dates to be determined by Sponsor (the "**Airfare**");
- (d) One (1) four-hundred-dollar (CAD \$400) pre-paid credit card (specific pre-paid credit card to be selected by the Sponsor in its sole discretion), such pre-paid credit card being subject to the terms and conditions associated with its use;
- (e) Two (2) Team-branded sweater (estimated retail value of CAD \$150); and
- (f) Two (2) Team-branded hat (estimated retail value of CAD \$100).

The total estimated retail value of the prize is CAD \$7,750. Actual retail value of the prize will depend on the winner's departure city and destination (the estimated retail values of the Airfare and Hotel are based on the departure city of Toronto and the destination of San Francisco). Any difference in value will not be awarded. Alcohol is not part of the prize.

5. PRIZE CONDITIONS:

- (a) Notwithstanding anything to the contrary herein, the winner must be available to attend the Games. Should the winner be unable to attend the Games, the prize will be forfeited in its entirety and may be awarded to an alternate winner in accordance with these Official Rules.
- (b) The Contest prize must be accepted as awarded and may not be transferred, resold, commercially traded, assigned, or redeemed for cash except at Sponsor's and RBJBP's sole and absolute discretion. Sponsor and RBJBP reserve the right to substitute any stated prize (or portion thereof) with an alternate prize of comparable or greater value at their sole and absolute discretion, for whatever the reason. All decisions of the Sponsor and RBJBP relating to the prize are final and are not subject to appeal. The Sponsor is not responsible for the prize once it has been redeemed. Prizes may not be exactly as advertised, and except as expressly warranted herein, any prize is provided "as is" without further warranty of any kind.
- (c) All prize details, including Airfare times, the location of the Hotel, and the Games' seat locations, will be determined in the sole discretion of Sponsor and/or RBJBP. Some restrictions may apply. Any unused portion of the prize will be forfeited. Each Prize Participant must be twenty-one (21) years of age or older. The winner is fully responsible for any and all applicable federal, provincial, and municipal taxes (including income and withholding taxes).
- (d) Use of any Major League Baseball game/event/exhibition ticket is subject to standard terms, conditions, and health and safety policies applicable to the ticket; see bluejays.com/ticketterms for details. Major League Baseball game, event and exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club, as applicable, and may be subject to change. The terms and conditions of the tickets awarded as part of the prize will govern in the event a legal game, event or exhibition, as defined by Major League Baseball, is not played or held, as applicable, due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason. The winner and their guests agree to comply with all applicable stadium and venue, as applicable, regulations in connection with the prize; see the applicable ticket terms and conditions for details. The applicable MLB Entities reserve the right to remove or to deny entry to any winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Game, event or exhibition. The Released Parties (defined below) will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppages, epidemic, pandemic, or any other issue concerning public health or safety, or any other event outside of their control that may cause the cancellation or postponement of any Major League Baseball game, event or exhibition. Major League Baseball game, event and exhibition tickets awarded as part of the prize may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the licence granted by the game, event or exhibition tickets.
- (e) Any and all additional costs and expenses associated with prize acceptance and use not specified herein as being provided, including, but not limited to, travel documentation (including valid passport for travel to the United States, if necessary), travel and health insurance, transportation costs not specified herein (including transportation to and from the Games), meals, gratuities and

other expenses incurred by the winner (and any guests) in claiming, accepting and/or using the prize are the sole responsibility of the individual winner. The winner must hold a valid credit card for check-in, incidentals, and security deposits as required by the Hotel.

6. **RANDOM DRAW:** At approximately 10:00 a.m. ET on Friday, November 6, 2026 (the “**Draw Date**”), a RBJBP representative, or other person designated by RBJBP, will select by random draw one (1) potential winner from among all eligible Entries received.

Odds of winning depend on the number of eligible Entries received during the Contest Period and whether entrants choose to submit Additional Entries.

7. **NOTIFICATION:** The potential winner selected in accordance with the previous section will be notified as follows:

- (a) If the Entry submitted by the potential winner was submitted via www.bluejays.com, the potential winner will be contacted by a RBJBP representative by telephone at the telephone number indicated in their Entry to determine if they are eligible in the sole discretion of the RBJBP representative.
- (b) If the Entry submitted by the potential winner was submitted via email, the potential winner will be contacted by a RBJBP representative by telephone at the telephone number indicated in their Entry to determine if they are eligible, in the sole discretion of the RBJBP representative.

In the event that any potential winner does not respond to such notification within two (2) business days, incorrectly answers the skill testing question (described in more detail below), as determined by Sponsor or RBJBP in its sole discretion, or declines a prize for any reason, they will be disqualified, the prize will be forfeited and, at Sponsor’s discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible Entries.

8. **DECLARING A WINNER:**

- (a) To be declared a winner and claim the prize awarded, the potential winner must (i) be eligible according to these Official Rules, (ii) correctly answer, without assistance of any kind, whether mechanical or otherwise, a time limited mathematical skill testing question which will be administered by telephone at a mutually agreeable time, and (iii) sign a duly completed Liability and, except where prohibited by law, Publicity Release form, and any other documentation as may reasonably be required by Sponsor and/or RBJBP, and return same to Sponsor (or if directed, RBJBP) by the date specified on the applicable documentation.
- (b) If all required documents are not properly executed and returned within the specified period of time, or the potential winner otherwise fails to comply with these Official Rules, a disqualification will result and the prize will be forfeited and, at Sponsor’s sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible Entries. The winner’s guests must also sign a duly completed Liability and, except where prohibited by law, Publicity Release form and return same to Sponsor (or, if directed, RBJBP) by the date specified in order to participate in the prize.

9. **WAIVER OF LIABILITY/PUBLICITY RELEASE:**

- (a) By participating in the Contest and submitting an Entry, each entrant (i) agrees to be bound by these Official Rules, including all Entry requirements, (ii) agrees that the decisions of Sponsor and RBJBP are final and without appeal, (iii) remises, releases and forever discharges Sponsor, RBJBP, the other MLB Entities, Meta Platforms, Inc. (formerly, Facebook, Inc.) (“**Facebook**”), Instagram, Inc. (“**Instagram**”), X Corp. (“**X**”), each of their respective parents, affiliated companies and

subsidiaries, any and all other companies associated with the Contest (including prize suppliers and suppliers of materials or services related to the Contest), and all of their respective employees, directors, officers, shareholders, agents, representatives, successors and assigns (collectively, the **“Released Parties”**) from any and all actions, causes of actions, suits, debts, dues, accounts, claims, damages, liability, losses, harm, costs or expenses, including without limitation any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, death, or property damage, arising out of, or in any way related to, directly or indirectly, the Contest, including without limitation the entrant’s participation in the Contest, any breach of these Official Rules, the awarding, receipt, possession, use and/or misuse of any Contest prize (or any portion thereof), and any travel or activity that is related to the receipt or use of any Contest prize, and/or the violation or infringement of any intellectual property rights or of any publicity, personality or privacy rights, and agrees to fully indemnify the Released Parties, Instagram, X, and Facebook from any and all claims by third parties relating to the foregoing.

- (a) The Released Parties are not responsible for (i) stolen, late, incomplete, illegible, inaccurate, misdirected, lost, misrouted, scrambled, damaged, delayed, undelivered, mutilated, postage-due or garbled entries, transmissions, email or mail; (ii) lost, interrupted or unavailable network, cable, satellite, server, Internet Service Provider, website, or other connections including those through and/or by any website; (iii) availability or accessibility or miscommunications or failed computer, satellite, telephone, cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (iv) failures or malfunctions of phones, phone lines or telephone systems, (v) any error, omission, interruption, defect or delay in transmission, processing, or communication; (vi) non-delivery of any communication or Entry; (vii) misdirected, blocked, or delayed email notifications; (viii) printing, typographical or other errors appearing within these Official Rules, in any Contest-related advertisements or other materials; (ix) any other errors, problems or difficulties of any kind whether human, mechanical, electronic, network, computer, telephone, mail, typographical, printing or otherwise relating to or in connection with the Contest, including, without limitation, errors or difficulties which may occur in connection with the administration of the Contest, the processing of Entries, the announcement of any prize in any Contest-related materials, or the cancellation or postponement of any Major League Baseball game, event or exhibition, (x) any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest; or (xi) any injury or damage to the computer of any entrant or other person related to or resulting from participating in this Contest or downloading materials from or use of any website.

and/or RBJBP, will be disqualified and all associated Entries will be void. Any attempt to deliberately damage the content or operation of this Contest is unlawful and subject to legal action by Sponsor, RBJBP, MLBAM and/or their respective agents. Sponsor and RBJBP shall have the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws relating to the Contest, and to resolve all disputes in their sole discretion. The Released Parties (i) make no warranty, guaranty or representation of any kind concerning any prize, and (ii) disclaim any implied warranty. The failure of Sponsor, RBJBP or MLBAM to enforce any term of these Official Rules shall not constitute a waiver of that provision. All disputes will be resolved in the Province of Ontario under applicable Ontario and Federal laws.

- (c) Sponsor, RBJBP and MLBAM reserve the right, in their sole discretion, to cancel, suspend or otherwise modify the Contest (or any portion thereof) and/or to amend these Official Rules at any time and in any way, without prior notice, for any reason, including, but not limited to incidents where a virus, bug, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Contest (or any portion thereof). In the event of cancellation, Sponsor and RBJBP may elect to identify a winner and award the prize by way of random drawing from among all non-suspect, eligible Entries received up to the time of such cancellation.
- (d) **CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEBSITE ASSOCIATED WITH THIS CONTEST OR UNDERMINE THE CONTENT OR LEGITIMATE OPERATION OF THIS CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR WILL DISQUALIFY ANY ENTRANT RESPONSIBLE FOR THE ATTEMPT, AND SPONSOR, RBJBP, MLBAM AND THEIR RESPECTIVE AGENTS RESERVE THE RIGHT TO SEEK DAMAGES (INCLUDING LEGAL FEES) AND OTHER REMEDIES FROM ANY PERSON(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.**

- (h) The provincial liquor authorities are not connected with this Contest in any manner whatsoever and are not liable in any way whatsoever in regard to any matter which relates to this Contest.
