

2026 Dawgs Take the Bayou Sweepstakes Presented By Northfield Park Racino
SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: The 2026 Dawgs Take the Bayou Sweepstakes Presented By Northfield Park Racino (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 21 years old) at the time of entry. Persons under the age of twenty-one (21) are not eligible to participate in this Sweepstakes under any circumstances. Any Entry received from a person under the age of twenty-one (21) may be automatically rejected and deleted. Enrollment in the Northfield Park Racino rewards program is free and no purchase is necessary to obtain a rewards number. Only one (1) bonus entry will be awarded per person, and each rewards number may be used for only one (1) bonus entry. Sponsor reserves the right to verify any rewards number submitted and to void any bonus entry associated with an invalid, duplicate or unverifiable rewards number. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete entries are void.
