

DENVER BRONCOS AND EMPOWER FAN FLY IN SWEEPSTAKES

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW. THIS SWEEPSTAKES CONTAINS A BINDING ARBITRATION CLAUSE.

- 1. INTRODUCTION:** The Denver Broncos Football Club ("Broncos"), located at 13409 Broncos Pkwy. Englewood, Colorado, 80112, is offering a sweepstakes ("Sweepstakes") in connection with Empower Retirement, LLC ("Empower"). Empower is acting solely as a promotional partner and prize contributor and is not the sponsor, administrator, or operator of the Sweepstakes and is not responsible for winner selection, notification, prize fulfillment, or administration of the Sweepstakes.. Empower will not be liable to any entrant in connection with the Sweepstakes.
- 2. ADMINISTRATOR:** The Sweepstakes is powered by Wit Labs, Inc. ("Administrator") on behalf of the Broncos and is accessible via the Administrator's website at [witcontests.com](https://www.denverbroncos.com/fans/contests) or through a mobile device or computer at <https://www.denverbroncos.com/fans/contests> (collectively, the "Platform"). For the avoidance of doubt, Administrator provides the Platform for the Sweepstakes but is not the sponsor of the Sweepstakes. By creating and using an account with Administrator, all entrants are further required to read and agree to the Administrator's [Terms of Service](#).
- 3. ELIGIBILITY:** Entrants, winners, and participants must be U.S. residents 18 years of age or older (or the minimum age required by law in the entrant's state of residence), excluding residents of the states of New York, Florida, and Rhode Island. Employees of the Broncos, Administrator, the NFL Entities (as defined below), and Empower ("Sweepstakes Entities") their respective parents, subsidiaries, affiliated companies, and agents, dealers, advertising and promotional agencies, wholesale distributors and individual retail licensees and the immediate family (defined as parents, spouse, children, siblings, grandparents) of each such employees, and all those with whom such employees are domiciled, are NOT eligible.

There will be three entry periods (each an "Entry Period") for the Sweepstakes with a drawing and prize awarded for each Entry Period. Non-winning entries from Entry Period #1 will be automatically rolled over and included in the drawing for Entry Period #2. Non-winning entries from Entry Period #2 (including those rolled over from Entry Period #1) will be automatically rolled over and included in the drawing for Entry Period #3.

Absolutely no entries will be accepted after the end date for each Entry Period of the Sweepstakes Period. Limit one (1) entry per person/email address. Enter only using an e-mail address subscribed and registered in your name. In the event of a dispute as to entries submitted by multiple individuals using the same e-mail account on the same day, entry will be deemed to have been submitted by the authorized subscriber of the e-mail account used to enter the sweepstakes at the actual time of entry. - 6. PRIZES/ODDS:** Odds of winning depend on the number of eligible entries received. The Broncos will select one (1) winner at the end of each Entry Period. Winners will be selected on the following dates: September 18, 2026 (for

September 27, 2026 prize), October 23, 2026 (for November 1, 2026 prize), and November 23, 2026 (for December 6, 2026 prize).

Prizes: The Broncos will award the following prizes: three (3) trip packages (one package per Entry Period) that each include round trip coach class air transportation for two (2) from a major U.S. airport of Broncos' choice near winner's residence to Denver, CO, \$100 Visa gift card, two (2) Bud Light Champions Club game tickets, hotel accommodations (double occupancy) for up to two (2) nights, two (2) pregame field passes, one (1) Broncos Player Jersey. 7. **WINNER SELECTION AND NOTIFICATION:** Winners will be selected via random drawing from eligible entries on or around September 18, 2026, October 23, 2026, and December 6, 2026. The winners will be notified by telephone/email. Winners must respond to such notification within 24 hours after notification or an alternate winner will be selected from the remaining eligible entries. Once a winner accepts the prize, they will be emailed information pertaining to the prize. No assignment, transfer or substitution of prize is permitted, except by the Broncos who may substitute a prize of equal or greater value. Limit one (1) prize per person or household.
8. **GENERAL CONDITIONS:** Winners will be required to execute and return to the Broncos a Prize Acceptance Agreement that includes representations of eligibility and liability/publicity releases, except where prohibited by law, and a properly completed I.R.S. 11. DISPUTES: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant, Broncos or Administrator in connection with the Sweepstakes, or any claim or dispute that has arisen or may arise between you and the Broncos and/or Administrator, shall be governed by, and construed in accordance with, the laws of the State of Colorado without giving effect to any choice of law or conflict of law rules. By participating in this Sweepstakes, each entrant agrees that: (i) any claim, dispute, or controversy (whether in contract, tort, or otherwise) arising out of, relating to, or connected in any way with the Sweepstakes or the awarding or redemption of prizes will be resolved exclusively by final and binding arbitration conducted pursuant to the AAA's Procedures for Consumer-Related Disputes in conjunction with the AAA's Commercial Arbitration Rules (if and as applicable depending on the amount in controversy); (ii) this arbitration agreement is made pursuant to a transaction governed by the Federal Arbitration Act ("FAA"), 9 U.S.C. §§ 1-16; (iii) the arbitration shall be held at the AAA regional office nearest the entrant; (iv) the arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the applicable entrant may have entered into in connection with the Sweepstakes; (v) the arbitrator shall apply Colorado law consistent with the FAA and applicable statutes of limitations and shall honor claims of privilege recognized at law; (vi) there shall be no authority for any claims to be arbitrated on a class or representative basis; arbitration can decide only the entrant's and/or the Broncos and/or Administrator's individual claims, and the arbitrator may not consolidate or join the claims of other persons or parties who may be similarly situated; (vii) the arbitrator shall not have the power to award punitive damages against any party; (viii) in the event that the administrative fees and deposits the entrant is required to pay under the AAA rules exceed \$125, and the entrant is unable to pay the additional fees and deposits, the Broncos retain the right to forward them to the AAA on the entrant's behalf, subject to ultimate allocation by the arbitrator. In addition, if the entrant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, the Broncos retain the right to pay as much of the entrant filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive; and (ix) if any part of this Arbitration Provision is deemed to be invalid or otherwise unenforceable or illegal, the balance of this Arbitration Provision shall remain in effect and shall be construed in accordance with its terms as if the invalid or illegal provision were not contained herein.
