

DENVER BRONCOS FORD BRONCO ENTER TO WIN SWEEPSKATES

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW. THIS SWEEPSTAKES CONTAINS A BINDING ARBITRATION CLAUSE.

- 1. INTRODUCTION:** The Denver Broncos Football Club ("Broncos"), located at 13655 Broncos Pkwy. Englewood, Colorado, 80112, is offering a sweepstakes ("Sweepstakes") in connection with Ford Motor Company ("Ford"). Ford is acting only as a prize provider and branding partner for the Sweepstakes and is not responsible for administering or conducting the Sweepstakes in any way. Ford will not be liable to any entrant in connection with the Sweepstakes.
- 2. ADMINISTRATOR:** The Sweepstakes is powered by Wit Labs, Inc. ("Administrator") on behalf of the Broncos and is accessible via the Administrator's website at [witcontests.com](https://www.denverbroncos.com/fans/contests) or through a mobile device or computer at <https://www.denverbroncos.com/fans/contests> (collectively, the "Platform"). For the avoidance of doubt, Administrator provides the Platform for the Sweepstakes but is not the sponsor of the Sweepstakes. By creating and using an account with Administrator, all entrants are further required to read and agree to the Administrator's [Terms of Service](#).
- 3. ELIGIBILITY:** Entrants, winners, and participants must be U.S. residents 18 years of age or older (or the minimum age required by law in the entrant's state of residence) and a resident of Colorado, Utah, Wyoming, Idaho or South Dakota. Employees of the Broncos, Administrator, the NFL Entities (as defined below), and Ford, their respective parents, subsidiaries, affiliated companies, and agents, dealers, advertising and promotional agencies, wholesale distributors and individual retail licensees and the immediate family (defined as parents, spouse, children, siblings, grandparents) of each such employees, and all those with whom such employees are domiciled, are NOT eligible.

Absolutely no entries will be accepted after the end of the Sweepstakes Period. Limit one (1) entry per person/email address. Enter only using an e-mail address subscribed and registered in your name. In the event of a dispute as to entries submitted by multiple individuals using the same e-mail account on the same day, entry will be deemed to have been submitted by the authorized subscriber of the e-mail account used to enter the sweepstakes at the actual time of entry. The authorized e-mail account subscriber is deemed to be the natural person who is assigned an e-mail address by an Internet access provider. No responsibility is assumed by Broncos or Administrator for any computer, on-line, telephone, human error or technical malfunctions that may occur. All entries become the property of Broncos and Administrator and will not be returned. By entering, you agree to these Official Rules and the decisions of the Broncos and Administrator, which are final and binding in all respects. Entering to win does not mean you have won.
- 6. PRIZES/ODDS:** Odds of winning depend on the number of eligible entries received. A group of five (5) finalists will be selected via a random drawing of all eligible entries on or about December 18, 2026. An additional random drawing from among the finalists will occur on or around the date of the Denver Broncos' last home game of the NFL season to select the Grand Prize winner.

Prizes: One "Grand Prize" winner will receive one (1) 2026 Ford Bronco ("Grand Prize"). Each finalist selected via random drawing will receive two (2) game tickets to a Denver Broncos Home Game valued at \$400 and a gift bag of Broncos merchandise valued at \$50. Entrants acknowledge that these games may be scheduled during the NFL's flexible scheduling window and the date and time of the games may be changed from what is originally reflected on the schedule and what may appear on the ticket or in these Official Rules. Neither Broncos nor Ford make any representation or warranty with regard to the condition of the Grand Prize, which is being provided on an "as is" "where is" basis. By entering the contest, each entrant acknowledges that Broncos and Ford will use the Grand Prize to promote the contest, including by driving the Grand Prize within and without the state of Colorado, and as such the Grand Prize will be delivered in "used" condition and may have been driven for a substantial number of miles before

being delivered to the winner. Prize packages do not include travel to or from Denver, ground transportation, meals, taxes, insurance, personal expenses, other incidental expenses or any other item not specifically described in these Official Rules, and all expenses for any of the foregoing are the sole responsibility of the winner. - 11. DISPUTES:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant, Broncos or Administrator in connection with the Sweepstakes, or any claim or dispute that has arisen or may arise between you and the Broncos and/or Administrator, shall be governed by, and construed in accordance with, the laws of the State of Colorado without giving effect to any choice of law or conflict of law rules. agrees that: (i) any claim, dispute, or controversy (whether in contract, tort, or otherwise) arising out of, relating to, or connected in any way with the Sweepstakes or the awarding or redemption of prizes will be resolved exclusively by final and binding arbitration conducted pursuant to the AAA's Procedures for Consumer-Related Disputes in conjunction with the AAA's Commercial Arbitration Rules (if and as applicable depending on the amount in controversy); (ii) this arbitration agreement is made pursuant to a transaction governed by the Federal Arbitration Act ("FAA"), 9 U.S.C. §§ 1-16; (iii) the arbitration shall be held at the AAA regional office nearest the entrant; (iv) the arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the applicable entrant may have entered into in connection with the Sweepstakes; (v) the arbitrator shall apply Colorado law consistent with the FAA and applicable statutes of limitations and shall honor claims of privilege recognized at law; (vi) there shall be no authority for any claims to be arbitrated on a class or representative basis; arbitration can decide only the entrant's and/or the Broncos and/or Administrator's individual claims, and the arbitrator may not consolidate or join the claims of other persons or parties who may be similarly situated; (vii) the arbitrator shall not have the power to award punitive damages against any party; (viii) in the event that the administrative fees and deposits the entrant is required to pay under the AAA rules exceed \$125, and the entrant is unable to pay the additional fees and deposits, the Broncos retain the right to forward them to the AAA on the entrant's behalf, subject to ultimate allocation by the arbitrator. In addition, if the entrant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, the Broncos retain the right to pay as much of the entrant filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive; and (ix) if any part of this Arbitration Provision is deemed to be invalid or otherwise unenforceable or illegal, the balance of this Arbitration Provision shall remain in effect and shall be construed in accordance with its terms as if the invalid or illegal provision were not contained herein.

- 12.
