

Baltimore Ravens Fan Flyaway Sweepstakes presented by Southwest Airlines Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

PURCHASING WILL NOT INCREASE YOUR CHANCES OF WINNING.

Void where prohibited or restricted by law, rule or regulation. This **Ravens Fan Flyaway presented by Southwest Airlines Sweepstakes** (the “Sweepstakes”) is subject to all applicable federal, state, local laws, rules and regulations. This Sweepstakes is powered by Wit Labs, Inc. (“Administrator”) on behalf of the Baltimore Ravens Limited Partnership (“Club”) and is accessible via the Administrator’s website at witcontests.com or through a mobile device or computer at <https://web.witcontests.com/ravens/sweepstakes/win/fan-flyaway-26067> (the “Website”) (collectively, the “Platform”). For the avoidance of doubt, Administrator provides the Platform for the Sweepstakes but is not the sponsor for the Sweepstakes. By creating and using an account with Administrator, all Entrants (as defined herein) are further required to read and agree to the Administrator’s [Terms of Use](#).

- 1. Eligibility:** This Sweepstakes is offered and open to persons who are legal residents of All 50 States and District of Columbia and nineteen (19) years of age or older as of the date of participation. Employees, officers, directors, agents and representatives of the Club, Administrator, Southwest Airlines Co. (“Southwest” or “Prize Provider”), the National Football League, its member professional football clubs, and NFL Ventures, LLC, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (collectively, the “Sweepstakes Releasees”), and each such individual’s immediate family members (husband, wife, mother, father, sister, brother, child, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. The Sweepstakes is subject to all applicable federal, state, and local laws. Void outside of the United States and where prohibited by law. - 2. Promotion Period:** Sweepstakes begins on Monday, July 27, 2026 at 9:00AM Eastern Time (“ET”) and ends on Saturday, August 29, 2026 at 11:59PM ET (hereinafter, “Promotion Period”). The Club’s computer is the official time keeping device for this Sweepstakes.
- 3. To Participate:** During the Promotion Period, to enter, all eligible Entrants must log onto <https://www.baltimoreravens.com/fans/sweepstakes/> and complete and submit the requested information on the form located on the Sweepstakes Entry Page. Entrants will be asked to provide their full name, date of birth, zip code, telephone number, and e-mail address (among other information). **Limit one (1) registration form submission per Entrant and per email address for the duration of the Promotion Period. Additional registration forms received from any such Entrant or email address after the first registration form received from that person or email address will be void.** The use of a script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void. Registration form submissions will be accepted throughout the Promotion Period, in accordance with the terms of these Official Rules. In the event of a dispute as to the identity of an Entrant based on the email address submitted, the entry will be deemed to be submitted by the person named on the applicable entry (regardless of whether that is the name of the authorized account holder of the email address from which said entry form was submitted), provided such individual is eligible according to these Official Rules.

The Club is not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, illegible, inaccurate, postage due or undelivered entries or mail, or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment,

programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, mail, or the announcement of the Prize; or for any injury or damage to Entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Club reserves the right, in its sole discretion, to void any entries of Entrants whom Club believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

4. **Winning Events:** The Sweepstakes will consist of one randomized drawing ("Prize Drawing") on or about Monday, August 31, 2026 from among all eligible entries received during the Promotion Period. Entries must be received before the end of the Promotion Period to be eligible for the Prize Drawing. Odds of winning a Prize (as defined herein) will depend upon the total number of eligible entries received. All potential Prize winners (each, a "Prize Winner" and collectively the "Prize Winners") will be notified by email and may be required to complete, sign and return an Affidavit of Eligibility and Publicity/Liability Release prior to the receipt of the Prize, or the Prize may be forfeited and awarded to an alternate winner. The Grand Prize will consist of two (2) tickets to a Baltimore Ravens away game (Prize Winner may choose the game; game must be a domestic game located in the United States of America – no international games) during the 2026 NFL season; roundtrip air travel for winner and one (1) guest on Southwest Airlines (subject to Air Travel Restrictions set forth below) to the city nearest the location for the Baltimore Ravens game selected by the Prize Winner; and two (2) nights hotel accommodations (standard room, double occupancy) for the game selected by the Prize Winner (Sponsor has sole discretion over hotel location). Prize does not include ground or other transportation to or from the airport, to the games or otherwise. Total Estimated Retail Value of each Grand Prize is approximately \$1,300.00. Prizes are awarded "as is" with no warranty or guarantee, either express or implied, by Club or Southwest.
