

Vikings Vote To Win Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Vikings Vote To Win Sweepstakes (the "Sweepstakes") is sponsored by Minnesota Vikings Football, LLC, 2600 Vikings Circle, Eagan, MN 55121 ("Vikings"), and administered by Wit Labs, Inc., 205 Woodcliff Boulevard, Morganville, New Jersey 07751 ("Wit Labs").

Entry Period: The Sweepstakes begins August 27, 2026, at 9:00AM CT, and ends September 10, 2026, at 11:59PM CT (the "Entry Period"). Wit Lab's computer is the Sweepstakes official clock.

Eligibility: To participate in the Sweepstakes, you must be at least eighteen (18) years of age on the date of entry and a resident of the United States of America (excluding residents of Florida, New York, and Rhode Island) and maintain a valid Wit Labs account associated with a valid email address at the time of entry and throughout the Entry Period. Void where otherwise prohibited. Employees of Vikings, Wit Labs or their affiliates, parent companies, marketing agencies, sweepstakes vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Sweepstakes and the immediate family members (including spouse, parents, siblings, and children, whether biological, adoptive or by marriage) or those living in the same household of each are not eligible to participate.

Entry: This Sweepstakes is powered by Wit Labs, on behalf of Vikings, and is accessible via the Wit Labs' website at [witcontests.com](https://web.witcontests.com), through a mobile device or computer. To participate in the Sweepstakes, entrants must agree to Wit Labs' Terms of Use. By creating and using a Wit Labs' account, entrants are further required to read and agree to the Wit Labs' Terms of Use.

During the Entry Period, entrants can go to <https://web.witcontests.com/vikings/sweepstakes/vote/vikings-rivalries-vote-to-win-260827> and follow the entry instructions to complete the online entry form. All entrants must accurately complete all required fields, or the entry will be deemed invalid. In order to participate in the Sweepstakes, entrants will need internet access and a valid email address.

Data rates may apply. Please check with your internet or wireless service provider for details on these and any other applicable charges. Entrants are solely responsible for any such internet or wireless charges.

Limit of one (1) entry per person. Participation in the Sweepstakes constitutes an entrant's full and unconditional agreement to these Official Rules and Vikings' and Wit Labs' decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. All entries must be received during the Entry Period. Use of any automated, robotic, repetitive, programmed, mechanical reproduction or similar systems or methods to participate is prohibited, will void any entry, and will result in disqualification.

Prize: One (1) winner will be selected in the Sweepstakes. The winner will receive the following prizes as described below (collectively, the "Prize"):

- (i) One (1) full-size Minnesota Vikings football helmet autographed by Randy Moss, and;

- (ii) Two (2) upper-level game tickets ("Tickets") (seat location selected by Vikings in its sole discretion), for the Minnesota Vikings home game against the Detroit Lions on December 20, 2026, (the "Game"), at U.S. Bank Stadium (the "Stadium").
 - i. Tickets are awarded pursuant to a revocable, nontransferable license that is personal to the winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed (except to a surviving spouse). A violation of these restrictions shall revoke the winner's license and may result in the prize not being honored.
 - ii. Winner and their guest must abide by all Vikings and Stadium policies, protocols, and ticket terms and conditions. Vikings reserve the right to revoke the tickets from winner and/or guests who do not abide by the aforementioned policies, protocols, or ticket terms and conditions, or who the Vikings or Stadium personnel deem, in their sole discretion, may be intoxicated, be a safety risk, or have violated any Stadium policy or law.
 - iii. All costs and expenses not specifically included herein, including but not limited to, transportation to and from the Stadium, are solely the winner's responsibility. If the winner elects to attend the Game without a guest, no additional compensation will be awarded. No refund or compensation will be made in the event of the cancellation of the Game.

The approximate retail value of the Prize is Eight Hundred Fifty-Five Dollars and Ninety-Nine Cents (\$855.99). Actual prize value is subject to fluctuations in the price of game tickets, and winner will not receive the difference between actual value and approximate value.

The odds of winning depend on the number of eligible entries received. Taxes on the Prize, including any federal, state, local, sales and income taxes (if applicable), are solely the responsibility of the winner, and winner agrees to provide a W-9 Tax form. Winner will not be required to make any payments to Vikings. Winner acknowledges that he or she will be issued a 1099 Form if the value of all prizes won (from any promotion) by winner from Vikings during the 2026 calendar year meets or exceeds Two Thousand Dollars (\$2,000) or other amount as determined by the IRS.

Winner Selection and Notification: A random drawing for the winner, among all eligible entries received, will be conducted on or about September 11, 2026, by a Vikings representative, whose decisions are final on all matters relating to the Sweepstakes. The winner will be notified by e-mail and must respond or reply to Vikings within five (5) business days. In the event a winner is unreachable, a winner's prize notification is returned as undeliverable, or a winner is not in compliance with these Official Rules, the winner will forfeit the prize. A forfeited prize may be awarded to an alternate winner in a random drawing from all remaining eligible entries received for the Sweepstakes. No substitutions are permitted except if the prize is unavailable, in which case the prize of equal or greater value may be awarded. Prize is not redeemable for cash.
