

## Grizzlies NBA Draft Lottery Scratch Off

### Presented by Southland Casino Hotel (“Sponsor”)

**OFFICIAL RULES.** The following rules (the “Official Rules”) apply to the below-referenced Promotion.

**PROMOTION PERIOD.** The “Grizzlies NBA Draft Lottery Scratch Off” (the “Promotion”) begins May 7, 2026 at 12:00 AM CST and ends May 10, 2026 at 6:00 PM CST (the “Promotion Period”). The Promotion is offered only in the states of Tennessee, Mississippi, and Arkansas, subject to the eligibility requirements set forth below. This promotion is not affiliated with or endorsed by the Tennessee Lottery.

**NO PURCHASE NECESSARY.** A purchase will not improve your chances of winning. Void where prohibited by law. This promotion is not a gambling activity under Tennessee law as it offers a free method of entry and winners are selected randomly, not based on any payment or consideration.

**ELIGIBILITY.** The Promotion is open only to legal residents of Tennessee, or legal residents of Arkansas or Mississippi living within one-hundred fifty (150) miles of FedExForum, who are at least twenty-one (21) years of age at the time of entry. Promotion is void outside this area and where prohibited by law. Employees of Memphis Basketball, LLC or its affiliated companies and agencies, Sponsor, the National Basketball Association (“NBA”) and its Member Teams, NBA Properties Inc., employees, agents, and each of their respective immediate families (parents, children, siblings, spouse) and household members are not eligible to participate in the promotion.

**TO ENTER.** During the Promotion Period, individuals (the “Entrants”) may enter the Promotion for an opportunity to win a prize (the “Prize”). Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. All entries become the property of Memphis Basketball, LLC and will not be acknowledged or returned. Entry is limited to one (1) entry per person per Promotion Period.

**PRIZE.** Odds and Prize inventory are fixed in advance and entries will be randomly selected as a winner (“Winner”) and will have a chance to receive an available Prize. The Prizes are:

**A. TWENTY (20) PERCENT OFF FANATICS ONLINE DISCOUNT CODE:** Codes are redeemable for 20% off online purchases, no exclusions. There are two thousand (2,000) of this Prize available.

**B. \$10 CASINO PROMOTIONAL FREE-PLAY VOUCHER (“FREE PLAY”) PROVIDED BY SPONSOR, A CASINO LAWFULLY OPERATING IN THE STATE OF ARKANSAS:** Only valid two weeks from issuance at Southland Casino Hotel, 1550 N. Ingram Blvd., West Memphis, AR 72301. Must have Lucky North account to use. Can join on property. Free Play has no cash value, is not redeemable for cash, and may not be sold, transferred, or substituted except as determined by Sponsor in its sole discretion. **G. CITY EDITION HAT:** The Winner will receive a City Edition hat. There is one (1) of this Prize available. (\$44.99 value)

**H. CITY EDITION LOGO T-SHIRT:** The Winner will receive a City Edition logo t-shirt. There is one (1) of this Prize available. (\$44.99 value)

**I. GAMEDAY LONG SLEEVE:** The Winner will receive a gameday long sleeve. There is one (1) of this Prize available. (\$89.99 value)

**J. CITY EDITION HOODIE:** The Winner will receive a City Edition hoodie. There is one (1) of this Prize available. (\$89.99 value)

**K. CITY EDITION CLAW BALL T-SHIRT:** The Winner will receive a City Edition claw ball t-shirt. There is one (1) of this Prize available. (\$59.99 value)

**L. CITY EDITION KNIT HAT:** The Winner will receive a City Edition knit hat. There is one (1) of this Prize available. (\$39.99 value)

**PRIZE VALUE.** The total Prize and all components thereof received by a single Winner will not exceed the value of \$100. Prizes are awarded "as is" with no warranty or guarantee, either express or implied. Winners will be responsible for all federal, state and local taxes and fees and other costs and expenses associated with Prize receipt and/or use that are not expressly included in the Prize description. No cash or other substitution, assignment or transfer of the Prize permitted, except by Memphis Basketball, LLC, who reserves the right to substitute any Prize or component of any Prize with cash or another prize of comparable or greater value. All Prize details are at Memphis Basketball, LLC's sole discretion. **INDEMNIFICATION.** By entering the Promotion, each Entrant agrees to hold harmless and indemnify Memphis Basketball, LLC, Sponsor, the City of Memphis, Tennessee, the County of Shelby, Tennessee, the NBA and its Member Teams, NBA Properties, Inc. and each of their respective direct and indirect parents, subsidiaries, affiliates, members, directors, officers, governors, employees and agents ("Released Parties") against any and all liability, damages or causes of action (however named or described), with respect to or arising out of either (i) such Entrant's participation, or (ii) the receipt or use of the prizes awarded in the Promotion.
