1. Eligibility: The Sweepstakes is open only to legal residents of the 50 United States or District of Columbia, excluding New York and Florida, who are at least 18 years old (or the age of majority in their jurisdiction of residence, whichever is older) at the time of entry.

2. Sweepstakes Period: The Sweepstakes starts 9:00 a.m. Eastern Time (ET) on April 18, 2026 and ends at 12:00 p.m. ET on April 22, 2026 (the “*Sweepstakes Period*”). All entries must be received during the Sweepstakes Period and meet other requirements in these Official Rules to be eligible to win a prize. Sponsor’s or its designee’s computer is the official time-keeping device for the Sweepstakes.

3. How to Enter: To enter, during the Sweepstakes Period visit sixers.com/fans/2026playoffssweepstakes and follow the instructions to enter the Sweepstakes, including entering your name, email address and phone number, and opt-in to receive marketing communications from Crypto.com when prompted by Sponsor in order to “enter the giveaway.” Upon completion of these steps, you will receive one entry into the Sweepstakes.

ALTERNATIVE METHOD OF ENTRY. In addition to entering the Sweepstakes via the above method, entrants may also enter the Sweepstakes by mailing in a 3x5 index card listing the entrant’s first name and last name to Philadelphia 76ers, L.P., 3 Banner Way, Camden, NJ 08103. Index cards must be received by 12:00 pm ET on April 24, 2026.

Limit one entry per person during Sweepstakes Period. For any entrants that submit an entry through the Alternative Method of Entry described above in addition to entering through the URL listed above, the Alternative Method of Entry and the entry through the URL shall count as one entry. Any attempts to obtain additional entries, including through multiple or duplicate accounts, will result in disqualification.

4. Identity of Entrant: All entries must be submitted by the individual entrant.
