

**Real Salt Lake & America First Credit Union – “America First Credit Union VIP Viewing Area Sign Up”
SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: Real Salt Lake & America First Credit Union – “America First Credit Union VIP Viewing Area Sign Up” (the “Sweepstakes”) is open to legal United States residents who live within a seventy-five (75) mile radius from America First Field at 9256 S State Street, Sandy, Utah 84070 (the “Territory”) who are at least eighteen (18) years of age and the legal age of majority in the jurisdiction in which they reside at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Real Salt Lake (“Club”), America First Credit Union (the “Sponsor”), Major League Soccer, L.L.C. (“MLS”), and Soccer United Marketing, LLC (“SUM”) and collectively with Sponsor and MLS, the “MLS Entities”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win the prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations.

HOW TO ENTER: The Sweepstakes begins at 9:00am MDT on June 1, 2026, and ends at 11:00pm MDT on June 25, 2026 (“Entry Period”). The clock of the Sponsor will be the official timekeeper for these Sweepstakes. During the Entry Period, there is one (1) permissible method to enter without purchase or obligation. Only the permissible method of entry will be accepted. There is a limit of one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry throughout the Sweepstakes period. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation (if any) will be void. By submitting your completed online entry form and all other requested information as directed, you will receive one (1) entry in the Sweepstakes (Viewing Area – Adults with dependents may bring immediate family with them – up to four (4) minors). Entrants must fully complete and

submit all non-optional data requested on the online entry form to be eligible. Incomplete entries will be void. No other method(s) of entry will be accepted. Entrants to the Sweepstakes will be given the option to receive commercial e-mails from MLS Entities; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails and consenting to do so will not increase your chances of winning.

Proof of submission is not considered proof of delivery to or receipt of such entry. Furthermore, Sponsor shall have no liability for any entry that is lost, intercepted or not received by the Sponsor.

By entering via online portal, you affirm that you have read, understand and agree to these Official Rules. Entrants understand that they are entering at their sole risk. Sponsor is not responsible for any claims arising from an entry specifically including, but not limited to, claims for intellectual property infringement and privacy rights violations, as well as violations of the respective social media site's terms and conditions.

The Prize will include but may not be limited to the following:

- Complimentary Food and Beverage

America First Field staff and/or Sponsor staff reserve the right, in their sole discretion, to veto, limit, or otherwise adjust the activities Winner chooses to do.

IF APPLICABLE: The Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). A disqualification will result, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate Winner may be randomly selected from among all remaining eligible entries if all required documents are not properly executed and returned within the specified period of time.
