**ELIGIBILITY:** The 2026 DEDICATED DAWGS SWEEPSTAKES PRESENTED BY CROSSCOUNTRY MORTGAGE (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. **HOW TO ENTER:** During the Promotion Period, an eligible entrant may enter by the method(s) listed below:
