

**COUNTDOWN TO PUCK DROP SWEEPSTAKES

Upon completion of these steps, you will receive one entry into the Sweepstakes. Limit one entry per person during Sweepstakes Period. Any attempts to obtain additional entries, including through multiple or duplicate accounts will result in disqualification.

If participating in this Sweepstakes via your mobile device (which service may only be available via select devices and participating wireless carriers and is not required to enter), you may be charged for standard data use from your mobile device according to the terms in your wireless service provider’s data plan. Six (6) of the potential prize winners will receive an autographed puck by a random Devils player. Approximate total Retail Value ("**ARV**") of each prize: \$100. One (1) of the potential prize winners will receive a Jack Hughes autographed jersey. Approximate total Retail Value ("**ARV**") of such prize: \$300. One (1) of the potential prize winners will receive a Nico Hischier autographed jersey. Approximate total Retail Value ("**ARV**") of such prize: \$300. Three (3) of the potential prize winners will receive an autographed jersey by a random Devils player. Approximate total Retail Value ("**ARV**") of each prize: \$300. One (1) of the potential winners will receive two (2) club tickets and parking to an October game at Prudential Center. Approximate total Retail Value ("**ARV**") of such prize: \$500. One (1) of the potential winners will receive two (2) lower level tickets to a 2026-27 Devils home game. Approximate total Retail Value ("**ARV**") of such prize: \$400.

Exact seating location and games (as applicable) shall be determined by DAE in its sole discretion.
