

2026 LUCKY FAN OF THE GAME SWEEPSTAKES PRESENTED BY DC LOTTERY

(the “Sweepstakes”)

OFFICIAL RULES & HOW TO ENTER (the “Official Rules”)

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Open only to legal residents of the fifty (50) United States and the District of Columbia (except residents of Florida, Rhode Island, and New York), who are eighteen (18) years of age or older (nineteen (19) years of age or older in Alabama and Nebraska). Void where prohibited. Eligibility determinations will be made by Sponsor (as defined herein) in its sole discretion and will be final and binding. Employees, agents, and representatives (and their immediate families (parent, child, spouse, or sibling, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related) of (1) Pro-Football LLC, d/b/a Washington Commanders (“PFL” or “Sponsor”), (2) the NFL Entities (defined below), and (3) DC Lottery, and their respective parents, affiliates, subsidiaries, and advertising, and promotion agencies are not eligible to enter or win. The NFL Entities shall be defined as the National Football League (“NFL”), its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC, and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives, and employees. By participating, entrants agree to be bound by these Official Rules and the decisions of PFL, which are binding and final on matters relating to this Sweepstakes. This Sweepstakes is subject to all applicable federal, state, and local laws. The Sweepstakes will consist of a random drawing to determine the winners among those participants who correctly enter the Sweepstakes under the guidelines stated herein. There will be nine (9) winners (“Winners”). Sponsor has the right, in its sole discretion, to modify these Official Rules (including without limitation by adjusting any of the dates and/or timeframes stipulated in these Official Rules) and to cancel, modify or suspend this Sweepstakes at any time in its discretion.

TIMING: Sweepstakes begins on July 27, 2026 at 12:00 PM Eastern Standard Time (“EST”) and ends on December 9, 2026 at 11:59 PM EST (the “Promotion Period”). PFL must receive all entries by the end of the Promotion Period.

ANY ENTRY RECEIVED AFTER THE CLOSE OF THE ENTRY PERIOD WILL NOT BE ACCEPTED.

HOW TO ENTER: There is one (1) way for participants to enter during the Promotion Period:

- **Online Website:** During the Promotion Period, individuals will click the following link <https://web.witcontests.com/commanders/giveaway/scratchnwin/dc-lottery-lucky-fan-of-the-ga-260726> to interact with the digital lottery-style mini game referred to as the ‘DC Lottery Lucky Fan of the Game.’ This will also be accessible through the Washington Commanders’ mobile app, official website, and via the Washington Commanders’ Instagram story. Participants will enter their information (first name, last name, date of birth, email, and zip code). PFL will then use a digital scratch off

platform to randomly draw nine (9) numbers. Participants who are chosen will be selected as the Winners. Participating in the game is free for all users, and no purchase is necessary to enter.

An entry is not received until the above task is completed by the participant. All entries must be received by the end of the Promotion Period to be eligible.

The following applies to all entries, regardless of entry method: Entries must be received during the Promotion Period. Proof of sent entry or entry receipt (such as a copy of a “thank you” message) does not constitute proof of actual receipt of entry by Sponsor for purposes of this Promotion. Limit one (1) prize per person, regardless of the number of entries during the Promotion Period. Entries generated by script, macro or other automated or mechanical means and entries by any means which subvert the entry process are void. Entries not legitimately submitted in accordance with these Official Rules are void. All entries become the property of PFL and will not be acknowledged or returned. Entries that are late, incomplete, copied, misdirected, mutilated, illegitimate, postage-due, inaccurate, illegible, lost, damaged, or generated by automated means are void. RANDOM DRAWING: PFL will select the potential Winners in a random drawing from among all eligible entries on three (3) separate occasions during the Promotion Period on or about (i) August 10, 2026 at 12PM EST, (ii) October 26, 2026 at 12PM EST, and (iii) December 9, 2026 at 12PM EST. Three (3) Winners will be selected from each drawing. Odds of winning depend on the number of eligible entries. PFL will conduct all drawings.

WINNER NOTIFICATION: The potential Winners will be notified by phone, e-mail, Washington Commanders mobile app notification or any other means in PFL’s sole discretion within two (2) days of each drawing. Except where prohibited by law, entry constitutes permission for Sponsor, its designees, affiliates, and licensees to use the potential Winners’ name, hometown, and likeness for online posting, and/or any advertising and publicity without additional compensation. The potential Winners will be required to execute and return an affidavit of eligibility, a liability release, intellectual property assignment and release, and a publicity release within forty-eight (48) hours of receipt. If (i) such documents are not returned within the specified time period, (ii) a prize or prize notification is rejected, faulty or returned as undeliverable, (iii) PFL is unable to contact a potential Winner within forty-eight (48) hours of notification, (iv) a potential Winner is not in compliance with these Official Rules, or (v) a potential Winner does not claim the prize within forty-eight (48) hours, then the prize will be forfeited and, at PFL’s discretion, alternate Winners will be randomly selected for the drawing at issue within a reasonable time, at PFL’s discretion and time permitting.

PRIZE: For each Winner, the prize consists of four (4) club-level tickets to a 2026 Commanders Home Game (specific games and location of seats to be determined by Sponsor and PFL) and one (1) Two Hundred Dollar (\$200) team store gift card (collectively, the “Prize”). Nine (9) Winners will be selected to receive the Prize. **The Total Approximate Retail Value for the Prize is One Thousand Five Hundred Dollars (\$1,500).** Actual value of Prize may vary based on dates of games. Sponsor reserves the right to substitute any portion of the Prize for one (1) of equal or greater value.

GENERAL PRIZE CONDITIONS: The Sponsor shall select the specific game, and location of such tickets and parking pass in its sole discretion. The Winners shall agree that the prize is awarded “as is” with no warranty, representation, or guarantee, either express or implied by Sponsor, in fact or in law, whether now known or hereinafter enacted, relative to the use or enjoyment of the prize, including, without limitation, its quality, merchantability, or fitness for a particular purpose. All prize details are at Sponsor’s sole discretion. The Winners may not substitute, assign, or transfer a prize or redeem a prize for cash, but Sponsor reserves the right, at its sole discretion, to substitute prize (or portion thereof) with one of comparable or greater value in the event an offered prize or portion of the prize becomes unavailable for any reason. The Winners are responsible for all applicable federal, state, and local taxes, if any, as well as any other costs and expenses associated with prize acceptance and use not specified herein as being provided. PFL will not replace any lost, mutilated, or stolen prize or any prize that is undeliverable or does not reach the Winners for any reason, including, without limitation, because of incorrect or changed contact information. PFL will provide an IRS 1099 Form to the Winners if the Winners are receiving a prize with an ARV that exceeds Six Hundred Dollars (\$600). No more than the stated prizes will be awarded.
