OFFICIAL RULES

MUST BE 18 YEARS OF AGE OR OLDER TO PARTICIPATE. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

This Sweepstakes is administered by Wit Labs, Inc. (the "Administrator"), and is accessible via the Administrator's website at [witcontests.com](https://www.witcontests.com) (the "Platform"). For the avoidance of doubt, the Administrator administers and provides the Platform for the Sweepstakes, but is not the sponsor for the Sweepstakes. To participate in the Sweepstakes, entrant must agree to the Administrator's [Terms of Use](#).

Eligibility: The Arizona Cardinals Kids Club Captain of the Game Experience Sweepstakes Presented by Raising Canes & Scheels ("Sweepstakes") is open to all Arizona residents, age 18 or older at the time of entry, and are parents or legal guardians of a child between the ages of five (5) and seventeen (17). Void where otherwise taxed, prohibited or restricted by law. 2. SWEEPSTAKES PERIOD: Sweepstakes begins at 5:00:00 p.m. Mountain Standard Time ("MST") on August 7, 2026 and ends at 11:59:59 p.m. MST on August 18, 2026 ("Sweepstakes Period"). The time clock of the Sweepstakes Administrator is the official clock for this Sweepstakes.

3. Drawing will be conducted by the Administrator, an independent judging organization, whose decisions in all matters relating to this Sweepstakes are final. The Administrator will determine, in its/their sole discretion, which entries are deemed Valid Entries, and their decisions and the result of the drawing will be final in all respects. Odds of winning depend on the total number of Valid Entries received.
