

Ally For the Crown Fan Wall Rules

Welcome to the Ally For The Crown Fan Wall Sweepstakes (the “**Sweepstakes**”), sponsored by Charlotte FC. **PLEASE READ THESE SWEEPSTAKES RULES CAREFULLY BEFORE ENTERING INTO THE SWEEPSTAKES.**

THERE IS NO PURCHASE OR PAYMENT NECESSARY IN ORDER TO ENTER OR WIN THE SWEEPSTAKES. ANY PURCHASE OR PAYMENT OF ANY KIND THAT YOU MAKE WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS, AND IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

This Sweepstakes is powered by Wit Labs, Inc. (“**Wit**”) on behalf of DT Soccer, LLC dba CharlotteFC (“**Sponsor**”), and is accessible via the Wit website at witcontests.com (the “**Platform**”). For the avoidance of doubt, Wit administers and provides the Platform for the Sweepstakes, but is not the sponsor for the Sweepstakes.

As a legal requirement for participating in this Sweepstakes as an entrant (“**Entrant**” or “**You**”) hereby agree to be bound by these Sweepstakes Rules (the “**Rules**”) which form a legal contract by and between You and Sponsor. **If You do not agree and consent to these Rules, please do not enter the Sweepstakes or use the Platform.** To participate in the Sweepstakes, You must agree to the Wit [Terms of Use](#).

- 1.1 Sweepstakes Description.** Entrant agrees to prepare and submit certain video, photo, information, documents, audio or other materials (“**Content**”) for evaluation subject to eligibility and in accordance with the Official Rules as described herein. After submission, Entrant may or may not be deemed a Winner (as defined in Section 3.1), subject to eligibility and compliance with these Rules. Prizes will be awarded for this Sweepstakes, and will be publicly displayed on the Sweepstakes Landing Page (as defined below).
- 1.2 Sweepstakes Period. Sweepstakes Start Date:** 2/17/2026 at 12AM ET. **Sweepstakes End Date:** 11/8/2026 at 11:59PM ET. The Sweepstakes will begin on the above Start Date, and will last through the above End Date (“**Sweepstakes Period**”). The Sweepstakes Period will be divided into three (3) entry periods (each, an “**Entry Period**”) as indicated in the chart below:

- 1.3 Rules.** By participating in the Sweepstakes, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agrees that the decisions of Wit or Sponsor with respect to the Sweepstakes and any prize awards shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. Any such changes to the Official Rules will be prominently displayed and any conflicting changes to the Official Rules will be superseded by the most recent version of the Official Rules.
- 1.4 Sweepstakes Administration.** Wit, on behalf of Sponsor, performs the collection, submission or processing of Entrant entry forms for the Sweepstakes (“**Entries**”), as well as the overall administration of the Sweepstakes. Entrant may contact Wit with any questions, comments or problems related to administration of the Sweepstakes. Wit may

be reached by email at team@witcontests.com during the Sweepstakes Period.

2. ELIGIBILITY.

- 2.1 Eligible Entrants.** The Sweepstakes is open only to legal residents of North Carolina or South Carolina who are 18 years of age or older. By participating, Entrants agree to be bound by these Rules and the decisions of Wit or Sponsor, which are binding and final on matters relating to this Sweepstakes.
- 2.2 Non-eligible Persons.** Sponsor, Ally Financial Inc., each of their parents, subsidiaries, affiliates, distributors, retailers, sales representatives, Sweepstakes administrator, advertising and promotion agencies; and each of their respective officers, directors, employees, consultants and contractors (Collectively, the "**Sponsor Entities**"), are ineligible to enter the Sweepstakes or win any related prize. "**Household Members**" means those people who share the same residence as any Sponsor Entity for at least three (3) months during a given year. "**Immediate Family Members**" means parents, step-parents, legal guardians, children, step-children, siblings, step-siblings or spouses of any Sponsor Entity. Household Members and Immediate Family Members of any Sponsor Entities are also not eligible to enter or win the Sweepstakes.
- 2.3 Minor Participants.** Persons under the age of 18 are not eligible to participate in this Sweepstakes. We will immediately reject and delete any Entry received from a person under the age of 18. Participants are required to provide truthful information, and we will reject and delete any Entry that we discover to be false or fraudulent.

3. PRIZES.

- 3.1 Prizes Awarded.** There will be ten (10) total winners; three (3) winners selected from Entry Period 1, three (3) winners from Entry Period 2 and four (4) winners from Entry Period 3. The winners will be randomly selected from eligible Entries on the Drawing Dates as described in Section 1.2. Odds of winning depend on the number of eligible entries received. Each winner will receive one (1) Charlotte FC 2026 Authentic Kit. Approximate Retail Value of each kit is \$175. All potential winners are subject to verification by Sponsor or Wit, whose decisions are final. All federal, state and local taxes and all other costs associated with prize acceptance and use not specified herein as being provided are the sole responsibility of the winner.
- 3.2** Prizes cannot be transferred, redeemed for cash or substituted by an Entrant. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater estimated value if a prize described in these Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The estimated value of the prize represents Sponsor's good faith determination. That determination is final and binding, and cannot be appealed. If the actual value of the prize turns out to be less than the estimated value, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any prize awarded. Sponsor will not replace any lost or stolen prize items.

4. HOW TO ENTER. Entrants may enter the Sweepstakes during any of the Entry Periods by visiting the Wit website and doing the following:

- 4.1** Upload your photo or video Content and successfully transmitting a completed online entry form as directed after visiting the Wit website at <https://web.witcontests.com/charlottefc/campaign/2026-for-the-crown-fan-wall-2026> (specified "**Sweepstakes Landing Page**"), and wait for it be approved. Your Content must be on topic for the Sweepstakes and Sponsor has full discretion in determining whether or not that holds true for your Content. Upon approval by Sponsor, you will be entered into the Sweepstakes.
- 4.2** Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete or inaccurate entries are void. All entries must include a valid email address for the Entrant.

- 4.3 ONLY ORIGINAL CONTENT IS ELIGIBLE TO WIN THE SWEEPSTAKES. Each Entrant must be the original creator of his/her submitted Content, and Sponsor reserves the right to validate that originality.
- 4.4 Entries that are deemed to be immoral, obscene, profane or not in keeping with Sponsor's image or in violation of these Official Rules will be void. In addition, to be eligible, Entry cannot include any third-party intellectual property, general property, likeness or imagery. Entry cannot defame or invade intellectual property rights of any person, living or deceased, or otherwise infringe upon any copyrighted, trademarked, or patented works or person's personal or proprietary rights
5. No Automated Entries. All automated or robotic Entries submitted by individuals or organizations will be disqualified. All Entries by Entrants must be made manually by such Entrants. Any attempt by an Entrant to submit multiple Entries by using multiple/different email addresses, phone numbers, identities, registrations, logins or any other methods will void such Entrant's Entries and that Entrant may be disqualified. Final eligibility for the award of any prize is subject to the eligibility verification of these Rules. All Entries must be submitted by the end of the Sweepstakes Period in order to participate. Wit's database clock will be the official timekeeper for this Sweepstakes.
6. Winner Selection. The winner(s) will be notified by e-mail on the Drawing Date (see Section 1.2). Sponsor and Wit are not responsible for any delay or failure to receive notification for any reason, including inactive account(s), technical difficulties associated therewith, or an Entrant's failure to adequately monitor the Wit app or website. Any winner notification not responded to by the Entrant, or returned as undeliverable may result in prize forfeiture. The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a publicity release (collectively "the **Prize Claim Documents**"). In the case of prizes that include guests, the potential prize winner understands and agrees that, as a condition of participation in the prize, guests may be required to sign and return a similar release of liability and a publicity release that grants Sponsor the same permissions for use of their names, likenesses and other information as set out in Section 8 below, and that refusal to sign those releases may result in guest being denied the ability to participate in the prize. 8. PRIVACY. Personally identifiable information ("**PII**") that is submitted by Entrant as part of this Sweepstakes will be used to administer the Sweepstakes, select and announce the winner. Entrant hereby waives any claims that Entrant may have or acquire against the Sponsor for libel, slander, invasion of privacy, copyright or trademark violation, moral rights, right of publicity, rights of privacy, or false light arising out of or in connection with such use. Entrant agrees that this waiver of privacy rights and constitutes a valid consent to uses of any PII as may be required under applicable data protection laws.
