

Mariners 50<sup>th</sup> Anniversary Season Pin Series Sweepstakes

**Official Rules**

Welcome to the Mariners 50<sup>th</sup> Anniversary Season Pin Series Sweepstakes (the “**Sweepstakes**”), sponsored by KeyBank National Association (“**Sponsor**”). **PLEASE READ THESE SWEEPSTAKES RULES CAREFULLY BEFORE ENTERING INTO THE SWEEPSTAKES.**

This Sweepstakes is powered by Wit Labs, Inc. (“**Wit**”) on behalf of Sponsor, and is accessible via the Wit website at [witcontests.com](http://witcontests.com) (the “**Platform**”). For the avoidance of doubt, Wit administers and provides the Platform for the Sweepstakes, but is not the sponsor for the Sweepstakes.

As a legal requirement for participating in this Sweepstakes as an entrant (“**Entrant**” or “**You**”) hereby agree to be bound by these Sweepstakes Rules (the “**Rules**”) which form a legal contract by and between You and Sponsor. **If You do not agree and consent to these Rules, please do not enter the Sweepstakes or use the Platform.** To participate in the Sweepstakes, You must agree to the Wit [Terms of Use](#).

Sweepstakes Description. Entrant agrees to prepare and submit the required entry form for the Sweepstakes (an “**Entry**,” collectively the “**Entries**”) in accordance with the Official Rules as described herein. After submission, Entrant may or may not be deemed a Winner (as defined in Section 3.1), subject to eligibility and compliance with these Rules. Prizes will be awarded for this Sweepstakes, and will be publicly displayed on the Sweepstakes Landing Page (as defined below).

Sweepstakes Period. **Sweepstakes Start Date:** April 19, 2026. **Sweepstakes End Date:** October 9, 2026. The Sweepstakes will begin on the above Start Date and will last through the above End Date (“**Sweepstakes Period**”).

Rules. By participating in the Sweepstakes, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agrees that the decisions of Wit or Sponsor with respect to the Sweepstakes and any prize awards shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. Any such changes to the Official Rules will be prominently displayed and any conflicting changes to the Official Rules will be superseded by the most recent version of the Official Rules.

Sweepstakes Administration. Wit, on behalf of Sponsor, performs the collection, submission or processing of Entries, as well as the overall administration of the Sweepstakes. Entrant may contact Wit with any questions, comments or problems related to administration of the Sweepstakes. ## ELIGIBILITY.

Eligible Entrants. The Sweepstakes is open only to legal residents of the United States and who reside in the State of Washington who are 18 years of age or older at the time of entry. By participating, Entrants agree to be bound by these Rules and the decisions of Wit or Sponsor, which are binding and final on matters relating to this Sweepstakes.

Non-eligible Persons. Sponsor, the MLB Entities, Sweepstakes administrator, each of their parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies; and each of their respective officers, directors, employees, consultants and contractors (the "**Sweepstakes Entities**"), are ineligible to enter the Sweepstakes or win any related prize. "**Household Members**" means those people who share the same residence as any Sweepstakes Entity for at least three (3) months during a given year. "**Immediate Family Members**" means parents, step-parents, legal guardians, children, step-children, siblings, step-siblings or spouses of any Sweepstakes Entity. Minor Participants. This Sweepstakes is subject to, and we comply with, all applicable laws relating to the collection of information from minors including the GDPR, CCPA, USA Children's Online Privacy Protection Act ("**COPPA**") and associated Federal Trade Commission ("**FTC**") rules. Persons under the age of 18 are not eligible to participate in this Sweepstakes under any circumstances. We will immediately reject and delete any Entry received from a person under the age of 18. Participants are required to provide truthful information, and we will reject and delete any Entry that we discover to be false or fraudulent.

## PRIZES.

Prizes Awarded. There will be one (1) total winner. The winner will be randomly selected from eligible Entries on or about October 19, 2026, after the conclusion of the Sweepstakes Period. Odds of winning depend on the number of eligible entries received. There will be **one (1) Grand Prize** consisting of two (2) Diamond Club tickets for winner and one (1) guest to a 2027 regular season Seattle Mariners home game, on a date mutually agreed upon by the winner and Sponsor (subject to availability and blackout dates), and the opportunity for winner and guest to attend a private batting practice viewing. Total Approximate Retail Value of the Grand Prize is \$1,450. Potential winner is subject to verification by Sponsor or Wit, whose decisions are final. All federal, state and local taxes and all other costs associated with prize acceptance and use not specified herein as being provided are the sole responsibility of the winner.

Prize cannot be transferred, redeemed for cash or substituted by an Entrant. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater estimated value if a prize described in these Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The estimated value of the prize represents Sponsor's good faith determination. That determination is final and binding, and cannot be appealed. If the

Exact nature and duration of the batting practice viewing shall be determined in the sole discretion of the Seattle Mariners and subject to availability. Use of any Major League Baseball game/event/exhibition ticket is subject to the standard terms, conditions, and health and safety policies applicable to the ticket; see [mariners.com/ticketback](http://mariners.com/ticketback) for details. Seat locations at the game/event/exhibition and, unless otherwise stated in the prize description, exact game/event/exhibition date shall be determined in the sole discretion of Sponsor. Winner's guest(s) must be of legal age of majority in their jurisdiction(s) of residence unless accompanied by a parent or legal guardian. Major League Baseball game/event/exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club and may be subject to change. The terms and conditions of the tickets awarded as part of the prize will govern in the event a legal game/event/exhibition, as defined by Major League Baseball, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. Sponsor and the MLB Entities will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any Major League Baseball game/event/exhibition. Major League Baseball game/event/exhibition tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game/event/exhibition ticket. A total of 10,000 Pins will be allocated to each Seattle Mariners game. At designated branch locations, 2,500 Pins per decade will be available. **Pins will be available on a first-come, first-served basis while supplies last.** After collecting a pin, eligible participants must successfully transmit a completed online entry form as directed after visiting the Wit website at <https://web.witcontests.com/keybank/scavenger/seattle-mariners-50th-season-p-260415>. (specified "**Sweepstakes Landing Page**"), you will receive one (1) entry into the Sweepstakes.

**Enter without a PIN:** Alternatively, you can enter by sending a 3" x 5" index card with your first and last name, mailing address, e-mail address and phone number to: Mariners 50th Anniversary Season Pin Series Sweepstakes, 4910 Tiedeman Road, Brooklyn, OH 44144. All mail-in entries must be postmarked during the Sweepstakes Period and must be postmarked by October 9, 2026 and received by October 16, 2026 to be eligible for the Drawing.

Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete or inaccurate entries are void. All entries must include a valid email address for the Entrant. **Limit one (1) entry per person, regardless of the method of entry.**
