

**The Minnesota Wild “Nordy’s Chipped Tooth Courtesy of Solventum Sweepstakes”
Official Rules**

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

This Sweepstakes, as defined herein, is powered by Wit Labs, Inc. (“Wit”) on behalf of the Minnesota Wild Hockey Club, LP (“Wild”) and courtesy of Solventum US LLC (“Solventum”) (collectively, the “Sweepstakes Entities”), and is accessible via the Wit website at witcontests.com (the “Platform”). For the avoidance of doubt, Wit administers and provides the Platform for the Sweepstakes, but is not the sponsor for the Sweepstakes. To participate in the Sweepstakes, entrants must agree to the Wit Terms of Use located at <https://witcontests.com/terms>.

1. ELIGIBILITY. The Minnesota Wild “Nordy’s Chipped Tooth Courtesy of Solventum Sweepstakes” (the “Sweepstakes”) is only open to entrants who, as of the entry date, are permanent legal residents of the United States and who are at least eighteen (18) years old. The Sweepstakes is void outside of the United States and where prohibited or restricted by law. Employees, officers and directors of the Wild and Solventum, and their respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies, and the immediate families (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter. The Sweepstakes, and any website pages and advertisements relating thereto, is intended for viewing only within the eligible Sweepstakes territory, and entrants must be present in the eligible Sweepstakes territory at the time they enter.

2. SWEEPSTAKES ADMINISTRATION. Wit, on behalf of the Sweepstakes Entities, performs the collection, submission or processing of entries, as well as the overall administration of the Sweepstakes. 3. SWEEPSTAKES PERIOD. The Sweepstakes period begins at **12:01 a.m.** Central Standard Time (“CST”) on **September 18, 2026**, and ends at **11:59 p.m.** CST on **November 9, 2026** (the “Sweepstakes Period”). Wit’s database clock is the official timekeeping device for the Sweepstakes.

4. HOW TO ENTER AND COMPLIANCE WITH OFFICIAL RULES

a. **HOW TO ENTER:** There are two (2) way(s) to enter this Sweepstakes.

- (1) **TO ENTER ONLINE:** During the Sweepstakes Period, go to <https://www.nhl.com/wild/fans/nordy-chipped-tooth> and follow the instructions for entry. All entries must be received by Wit during the Sweepstakes Period. Potential winners may be required to show proof of being the authorized entrant. **LIMIT:** One (1) entry per person and address (physical or email) per day in the Sweepstakes.
- (2) **TO ENTER VIA MAIL:** **LIMIT:** One (1) mail in entry per person and address per day (physical or email) in the Sweepstakes. All entries must be received by Wit during the Sweepstakes Period and become the exclusive property of the Sweepstakes Entities. None will be acknowledged or returned. All entrants and entries subject to verification prior to the awarding of a prize, as are the eligibility, age and other claims of/information provided by a potential prize winner. All entries may be sent

b. **COMPLIANCE WITH OFFICIAL RULES:** Failure to submit all required information in the manner required in these Official Rules may result in disqualification. Entries will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sweepstakes Entities or Wit. Any submission that does not comply with any aspect of these Official Rules may be rejected by the Sweepstakes Entities or Wit and the entrant disqualified.

5. AGREEMENT TO OFFICIAL RULES AND DECISIONS. By participating in the Sweepstakes, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of the Sweepstakes Entities (including, without limitation, decisions regarding eligibility of entries, the selection of entrants and the winners, and the awarding of prizes), which are final and binding in all respects.

6. SELECTION OF WINNING ENTRY; ODDS; NOTIFICATION. On or about **November 10, 2026**, the Sweepstakes Entities, in their sole discretion, will select one (1) winner from among all eligible entries received. The winner will be notified by phone or email and will be required to execute a Liability and Publicity Release. The approximate retail value (“ARV”) of the prize is one thousand three hundred and 00/100 U.S. dollars (\$1,300.00). Prize must be accepted as awarded, and prize is awarded “AS IS” with no warranty, representation, or guarantee, express or implied, in fact or in law, made by the Sweepstakes Entities and Wit or for which the Sweepstakes Entities and Wit shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE.
