

AWAY X SABRINA IONESCU LUGGAGE GIVEAWAY SWEEPSTAKES:

OFFICIAL SWEEPSTAKES RULES

1. Sweepstakes Description: The following terms and conditions apply to that certain New York Liberty, LLC (“**NYL**”)-administered sweepstakes known as the *Away x Sabrina Ionescu Luggage Giveaway Sweepstakes* (the “**Sweepstakes**”). 2. Sweepstakes Period: The “**Sweepstakes Period**” means the period of time beginning at 9:00 AM ET on August 30, 2026, and ending at 11:59 PM ET on September 7, 2026. In order to qualify, entries must be received during the Sweepstakes Period. Any entries received thereafter shall be null and void, and ineligible for the Sweepstakes. NYL is not responsible for late, incomplete, or misdirected entries, nor is it obligated to publicly announce the Sweepstakes results.

3. To Enter: NO PURCHASE NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE OR IMPACT YOUR CHANCES OF WINNING. In order to be entered into the Sweepstakes, an eligible entrant (“**Entrant**”) must, during the Sweepstakes Period, enter the Sweepstakes in the manner described above.

Limit: one (1) entry per person. If an Entrant completes more than one (1) Sweepstakes entry form, only the first Sweepstakes entry form will be considered. All entries become the property of NYL.

By entering the Sweepstakes in the manner described above, an Entrant consents (a) to being contacted by NYL, JRSK INC., D/B/A AWAY, and their respective affiliates and designees (collectively, the “Sweepstakes Parties”); and (b) to be bound by, and comply with, all of the terms and conditions set forth in these Official Sweepstakes Rules.

4. Eligibility: VOID WHERE PROHIBITED. Entrants must be at least 18 years of age at the time of entry and reside within the State of New York, New Jersey, or Connecticut. Sweepstakes is void where prohibited or restricted by law. Employees, officers and directors (and their parents, siblings, spouses and

children) of: (a) the Sweepstakes Parties; (b) their respective advertising or promotional agencies; and (c) their respective parents, subsidiaries or affiliates, are not eligible to participate in the Sweepstakes.

NYL shall not be responsible for failed attempts to notify a Winner and no responsibility is assumed by NYL for any correspondence returned as undeliverable or any other problems associated with attempt(s) to notify a Winner. Odds of winning depend upon the number of eligible entries received.

6. Winner Verification: Upon the request of NYL, each Winner must sign and return the following documents: (a) an affidavit of eligibility; (b) a liability/publicity release in form and substance satisfactory to NYL; and (c) any other releases and waivers requested by NYL, releasing the Sweepstakes Parties from any and all liability, loss, claims, demands and causes of action for or related to personal injury, damage, theft, loss, or any other harm suffered in connection with the Sweepstakes or the Prize. Claims/Choice of Law: (a) Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorneys' fees; and (b) under no circumstances will Entrant be permitted to seek the award of, and Entrant hereby waives all rights to claim, punitive, incidental and consequential damages or any other damages, other than actual out-of-pocket expenses, and hereby waives all rights to have damages multiplied or otherwise increased.
