Sweepstakes Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Baltimore Ravens 2026 Ravens First Round Draft Pick Vega Ioane Sweepstakes (the "**Sweepstakes**") is sponsored by Baltimore Ravens Limited Partnership (1 Winning Dr., Owings Mills, MD 21117) ("**Ravens**"). By participating in the Sweepstakes, you agree to be bound by these Official Rules, including entry requirements.

1. **Entry Period:** The Sweepstakes begins 18th May 2026 at 8:00 a.m. BST, and ends 12th June 2026, at 11:59 p.m. BST (the "**Entry Period**"). Ravens' computer is the Sweepstakes official clock.
2. **Eligibility:** To participate in the Sweepstakes, you must be at least eighteen (18) years of age on the date of entry and a legal resident of the United Kingdom. Employees of Ravens or its affiliates, parent companies, marketing agencies, sweepstakes vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Sweepstakes and the immediate family members or those living in the same household of each are not eligible to participate.

Entrants must fully complete and submit all nonoptional information requested on the registration form to be eligible. Incomplete and inaccurate entries are void and will be disqualified.
 - a. Participation in the Sweepstakes constitutes an entrant's full and unconditional agreement to these Official Rules and Ravens' decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.
 - b. Limit of one (1) entry per person.
4. **Prize: There will be one (1) prize in the Sweepstakes.** The prize will consist of one (1) Baltimore Ravens Vega Ioane Autographed Football. The odds of winning depend on the number of eligible entries received. Winner will not be required to make any payments to Ravens.
5. **Winner Selection and Notification:** A random drawing for the winner, among all eligible entries received, will be conducted on or about 8th May 2026 via random computer process, and such decisions are final on all matters relating to the Sweepstakes. The winner will be notified by e-mail and must respond or reply to Ravens within seven (7) business days. In the event a winner is unreachable after three (3) attempts, a winner's prize notification is returned as undeliverable, or a winner is not in compliance with these Official Rules, the winner will forfeit the prize. A forfeited prize may be awarded to an alternate winner in a random drawing from all remaining eligible entries received for the Sweepstakes. No substitutions are permitted except if the prize is unavailable, in which case the prize of equal or greater value may be awarded. Prize is not redeemable for cash. Except to the extent prevented by applicable law, Ravens will make available the surname and county of residence of the winner(s) to anyone who sends a request to contact.us@ravens.nfl.net within one (1) month after the expiry of the closing date. If any entrant objects to any or all of their surname and county being published or made available, please contact contact.us@ravens.nfl.net. In such circumstances, Ravens may still provide the information to a relevant regulator on request.

6. **Ravens' Responsibility.** Nothing in these Official Rules shall exclude or limit in any way Ravens' liability to you in respect of: (i) death or personal injury caused to any entrant as a result of Ravens' negligence; or (ii) fraud or fraudulent misrepresentation or for any other liability where such exclusion or limitation is not permitted by law.

We will not be responsible to you for (and will have no responsibility to you in connection with) any occurrences beyond our control, including but not limited to any alteration, unauthorized access, damage, late delivery or non-delivery of any entries, notices, acceptances, requests or other documents related to the Sweepstakes, to the extent caused by errors in or unavailability of third-party networks or systems.

In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason outside of the Ravens' control, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem suffered by the supplier of the systems that Ravens relies on to operate and administer the Sweepstakes, Ravens may either: (a) suspend the Sweepstakes until it has addressed the impairment; or (b) terminate the Sweepstakes and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment.

7. **Disqualification.** Ravens reserves the right to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempted form of participation in the Sweepstakes other than as described herein is void.

9. **Additional Terms.** In the event production, printing, human or other errors cause more than the stated number of prizes to be available and/or claimed, Ravens reserves the right, in its sole discretion, to either (i) award the prize by random drawing among all eligible claimants who submitted legitimately, or (ii) terminate the Sweepstakes with notice and award the prize in a random drawing among eligible claimants who submitted legitimately received entries. In no event will Ravens be liable for awarding more than the stated number of prizes.
10. **General.** If any provision of these Official Rules or any word, phrase, clause, sentence, or other portion thereof should be held unenforceable or invalid for any reason, then that provision or portion thereof shall be modified or deleted in such manner as to render the remaining provisions of these Official Rules valid and enforceable. The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. Ravens' failure to enforce any term of these Official Rules shall not constitute a waiver of that provision and such provision shall remain in full force and effect.

English law will apply to all disputes and the interpretation of these Official Rules. The English courts will have non-exclusive jurisdiction over any dispute arising from or related to the Sweepstakes (including the Prize). This does not, however, affect your rights under the law of the country in which you are resident, including (where applicable) your right to have a dispute in relation to your participation in the Sweepstakes heard in the courts of that country.
